EXECUTIVE SUMMARY

This Working Paper presents the status of implementation of the Decisions and Recommendations made by the 11th Comprehensive Regional Implementation Plan for Aviation Security and Facilitation in Africa (AFI SECFAL Plan) Steering Committee Meeting, held in Abuja, Nigeria on 17 May 2022. Details are provided in **Attachment A** appended to this Working Paper.

Action by the SC is proposed under Paragraph 4.

1. BACKGROUND INFORMATION

- 1.1 The Eleventh Meeting of the AFI SECFAL Plan Steering Committee (SC) was held on 17 May 2022. Five Decisions and one Recommendation were made, which required action by the Secretariat and other stakeholders.
- 1.2 The meeting was informed that all activities under the 2022 Plan Work Programme fall under the Plan Long-term phase (2021-2023) and are aligned with the Global Aviation Security Plan (GASeP) and Windhoek Targets. The ultimate and collective aspirational target for all activities is to have ninety percent (90%) of States in the region reach above eighty percent (80%) of the Effective Implementation (EI) of the Critical Elements (CEs) of State Aviation Security Oversight system, by the end of the year 2023.

2. DISCUSSION

2.1 During the period from May 2022 to August 2023, several of the Decisions and Recommendations have been fully implemented and some have their implementation ongoing. Those not completed, have been incorporated in the extended AFI SECFAL Plan Work Programme (2024-2030) for purposes of implementation continuity. Details of implementation status are highlighted in Attachment A of this Working Paper. As mandated, the Secretariat will continue to update the SC on the implementation status during statutory meetings.

- 2.2 Mr. Barry Kashambo, the former Regional Director, ICAO ESAF Office, and Executive Secretary for the AFI SECFAL Plan has retired. He has been replaced by Mrs. Lucy Mbugua, the new Regional Director for ICAO ESAF Office., and she has assumed the role as the new Executive Secretary of the AFI SECFAL Plan.
- 2.3 The removal of COVID-19 related travel restrictions has supported the expeditious implementation of the 2022-2023 Plan work programme with emphasis on State specific projects, including capacity building efforts through workshops, seminars and training courses which have enabled the implementation of most of the 11th SC Decisions and Recommendations.

3. CONCLUSION

- 3.1 The AFI SECFAL Plan secretariat remains focused on completion of the implementation of the yet to be implemented Decisions and Recommendations of the previous Steering Committee meeting, including but not limited to the following persistent challenges:
 - a) Delayed resolution of existing Significant Security Concerns (SSeCs) and low EI in some States due to lack of prioritization of aviation, inadequate legislative provisions, inadequate funding at State level and lack of a sustainable AFI SECFAL Plan funding mechanism to support the critical assistance activities;
 - b) Inadequate civil aviation infrastructure, inability to comply with ICAO SARPs, slow attainment of Windhoek and GASeP targets and inadequate implementation of the relevant UN Security Council Resolutions;
 - c) Lack of real time data to facilitate decision-making and planning, resources allocation and prioritization of activities;
 - d) Unreliable funding, to implement the State specific projects; and
 - e) New and emerging security threats to civil aviation.

4. ACTION BY THE STEERING COMMITTEE

- 4.1 The Steering Committee is invited to:
 - a) Note the information contained in this paper and in particular the implementation of the Recommendations and Decisions as highlighted in Attachment A to this Working Paper;
 - b) Provide further instruction, guidance and recommendations for the continued implementation of the Plan; during the extended period of seven (7) years (2024-2030); and
 - c) Continue the advocacy to establish a sustainable funding mechanism for the Plan and explore potential options to secure long-term financial support.
