Criteria of prioritization

1. States with Significant Security Concerns SSeCs

2. States with El of the CE below 50%,

3. States with El above 50% but below 65%

4. States with El above 65%.

State specific projects

- Five State specific projects to be developed :
 - Mali;
 - Malawi;
 - Seychelles;
 - Somalia; and
 - The Gambia
- Follow up activities State-specific projects to six SSeCs States



Support to USAP CMA CAP implementation

- Four State to be supported :
 - 2 in ESAF; and
 - 2 in WACAF;

Support to States to implement Annex 9 provisions

- Two Annex 09 FAL Courses for AFI States:
 - One in ESAF (English); and
 - One in WACAF (French)
- FAL ipack for Libya
- Two ICAO TRIP Strategy Courses for AFI states in French to be hosted by WACAF;
- One seminar in the AFI on API /PNR /PKD /SLTD.



Other activities

- Two regional Risk Management Workshops for AFI;
- Two regional Crisis Management Workshops for AFI;
- Two Cyber Security Webinars/Workshops for AFI;
- Two Quality Control Workshops for AFI;
- Two National Inspectors Course for AFI;
- Two trainings/workshops on security culture
