1.1 This paper provides a summary of annual ASTCs (ESAF and WACAF) activities in the year 2019. It also highlights the assistance provided by ICAO through ISD-SEC sponsored courses and hosted by the ASTCs. Finally, the initiatives taken by ASTCs towards developing e-learning and virtual classroom programs during the COVID 19 pandemic is reviewed.

2.4 Each ASTC had conducted training on both ICAO Aviation Security Standardized training package and non- ASTP material to participants from various member countries in both ESAF and WACAF regions, and in some instances the participation came from outside the two regions.

### 3. AFI ASTCs COOPERATION

3.1 All the five centers have a mutual agreement to be meeting annually to discuss issues impacting on ICAO Audit findings on Critical Element number 4 (CE4) to include the following areas;

- AVSEC Course development
- Sharing of available SMEs in the region,
- Common approach to issues raised in ICAO global forums relating to AVSE Training;
- Coordination of annual training plans for optimal participation by member states.

3.2 To this end the centers have met twice and are currently developing terms of reference to guide them in their cooperation.

### 4. ASTCs INITIATIVES DURING COVID-19 PANDEMIC

4.1 In the last virtual meeting of ASTCs on 23<sup>rd</sup> July 2020, it was observed that centers need to come up with e-learning and virtual class room material as this may be the new norm in the post COVID19 period.

4.2 Most Centers reported that the idea is still at inception stage and plans are underway to develop infrastructure for the e- learning programs and virtual classrooms.

4.3 For those who reported to have started developing new programs on e-learning and virtual classroom material, they were advised to bench mark with other ASTCs from other regions who may have well established systems to improve what they have developed in their contexts.

**5. ACTION BY THE AFI-SECFAL STEERING COMMITTEE**

5.1 The AFI-SECFAL Steering Committee is invited to:

- a) Note the cooperation between the AFI( ESAF and WACAF) – ASTCs in coordination of AVSEC training programs;
- b) Take note of the scope of participation by ICAO contracting states in the AFI region in programs planned by the ASTCs using ICAO ASTPs;
- c) Share information on any new development in the global arena impacting on the AVSEC personnel training;
- d) Give advisory support on the best practices in developing recovery protocols in the post COVID19 period at the training centers; and
- e) Support the ASTCs Initiatives in developing e-learning and virtual classroom material.
