## 1 INTRODUCTION

- 1.1. The meeting may recall that the Joint APIRG/RASG-AFI Coordination Task Force was established as a contributory body to APIRG and RASG-AFI and is responsible for coordinating the activities of APIRG and RASG-AFI on a routine basis. The ARC-TF should discuss common and urgent issues and report to the APIRG and RASG-AFI.
- 1.2. This paper presents the updated APIRG, RASG-AFI and AFI Plan common areas and activities as revised by the ARC -TF/7.

## 2 DISCUSSION

- 2.1 The Seventh meeting of the APIRG/RASG-AFI Coordination Task Force (ARC- TF/7), held virtually on 17 October 2024, reviewed, and endorsed the allocation of tasks and the areas of common interest between APIRG and RASG-AFI as well as AFI Plan as presented by the Secretariat.
- 2.2 The review of the allocation of tasks and the areas of common interest between APIRG and RASG-AFI is part of the ARC-TF terms of reference and work Programme, with the aims of facilitating consistency and efficiency, and ensuring avoidance of duplication and conflict between the activities of APIRG and RASG-AFI.
- 2.3 To ensure the continuous consistency, efficiency, and lack of duplication and conflict between the activities of APIRG, RASG-AFI and the tasks allocated to RASG-AFI contributory bodies, areas of common interest need to be aligned. The paper provides the revised common areas between the two Groups as well as the AFI Plan. The attachment provides an updated list of common areas.
