




Competency. A combination of skills, knowledge and attitudes required to perform a task to the prescribed standard.

- Performance standards
- Assessments
 - Competencies achieved?

Competency Framework

- Competency units
 - Discrete function
 - Contains competency elements
- Competency elements
 - Action
 - Triggering event
 - Terminating event
 - Defined limits
 - Observable outcome
- Performance criteria
 - Required outcome of competency elements
 - Criteria to judge if performance achieved



4.4 COMPETENCY-BASED TRAINING AND ASSESSMENT

Competency-based training and assessment should be used in accordance with the general provisions contained in Chapter 2 of the Procedures for Air Navigation Services — Training (PANS-TRG, Doc 9868).







Assess packing options including quantity limitations


Apply packing requirements






