Sir/Madam,

I wish to invite your Administration/Organization to attend the ICAO Extended Diversion Time Operations (EDTO) Workshop to be held in Nairobi, Kenya, from 28 October to 1 November 2019.

As you may be aware, the first edition of Doc 10085 - Extended Diversion Time Operations (EDTO) Manual which was published by ICAO in November 2017 provides guidance on the implementation of the EDTO provisions of Annex 6, Part I as per Amendment 36 and contains best practices on extended range operations by aeroplanes with two turbine engines (ETOPS) or more.

The EDTO workshop which will be mainly based on the said ICAO manual will enable States to enhance processes on the granting of AOC related specific approvals on extended range operations, and air operators to plan and conduct related operations in compliance with regulatory requirements.

Therefore, it is strongly recommended that operations of aircraft and airworthiness inspectors of Civil Aviation Authorities (CAAs) and Regional Safety Oversight Organizations (RSOOs) as well as appropriately qualified operations personnel be nominated to attend the Workshop. In this respect, CAAs are invited to extend this invitation letter to air operators under their supervision.
