Subject: Fourth Meeting of the APIRG Airspace and Aerodrome Operations Sub-Group (AAO/SG4), Virtual meeting, 16 to 18 August 2021

Action required: To register preferably not later than 13 August 2021

Sir/Madam,

I wish to recall the Twenty third Meeting of the Africa-Indian Ocean Planning and Implementation Regional Group (APIRG/23), held virtually, 23rd November to 2nd December 2020, which adopted the 2020-2021 APIRG Work Programme in accordance with the APIRG Procedural Handbook. I would like to invite your Administration/Organization to participate in the Fourth Meeting of the APIRG Airspace and Aerodrome Operations Sub-Group (AAO/SG4), to be held virtually, from 16 to 18 August 2021.

The AAO/SG4 will review Conclusions and Decisions of the AAO/SG3 and APIRG/23 meetings, as well as the status of the implementation of Projects. The ASBU Modules implementation status for which the Region has to report will be emphasized.
