1. INTRODUCTION

- 1.1. In accordance with the provisions in Appendix F of ICAO Doc 9766, Volcanic ash exercises should be conducted by ICAO on a regional basis in order to practice and develop inter-agency response to volcanic activity, in order to maintain safety, regularity and efficiency of aviation in the event of a volcanic eruption.
- 1.2. Furthermore, A volcanic ash exercises steering group may be established by a PIRG [ICAO Planning and Implementation Regional Group] to coordinate all aspects of the organization and conduct of the exercises. The steering group should have representatives from, as a minimum, the volcanic ash advisory centres (VAACs) concerned, air navigation service providers (ANSPs), airspace users and regulators.
- 1.3. The terms of reference of the AFI VOLCEX/SG, as adopted at the Twenty-fourth Meeting of the AFI Planning and Implementation Regional Group (APIRG/24), through its *Decision 24/02 Establishment of a Volcanic Ash Exercises Steering Group in the AFI Region*, is provided at **Appendix 1** to this paper for review and possible update by the meeting.
- 1.4. This paper proposes a review and an update of the TOR of the Steering Group to adapt it to the context.

2. DISCUSSIONS

- 2.1. The terms of reference of the AFI VOLCEX/SG are based on the guidance contained in *ICAO Doc* 9766 Handbook on the International Airways Volcano Watch, Appendix F Guidance for conducting volcanic ash exercises in ICAO Regions.
- 2.2. A proposed update to the terms of reference document of the AFI VOLCEX/SG is provided at the **Appendix 2** to this paper to provide additional guidance on attributes of the AFI VOLCEX/SG including the composition, administration, and functions of the group.
