**1. INTRODUCTION**

- 1.1 The Twenty-fifth Meeting of the AFI Planning and Implementation Regional Group (APIRG/25) and the Eighth Meeting of the AFI Regional Aviation Safety Group (RASG-AFI/8) were held in Kigali, Rwanda from 7 to 11 of November 2022.
- 1.2 The APIRG/25 meeting adopted twenty-one (21) Conclusions and twenty-five (25) Decisions. In accordance with the RASG-AFI and APIRG, actions are recorded in the form of Conclusions and Decisions that are defined as follows:
  - a) Conclusions deal with matters which, in accordance with the Groups' terms of reference, merit directly the attention of States, or on which further action is required to be initiated by the Secretary in accordance with established procedures.
  - b) Decisions relate to the internal working arrangements of the Groups and their subsidiary bodies.

## 2. DISCUSSION

- 2.1 The Group was presented with information on the status of implementation of the Conclusions and Decisions adopted by the APIRG/24 meeting. The meeting noted the progress made and activities undertaken by the Secretariat, States and Stakeholders on the implementation of Conclusions and Decisions adopted by the APIRG/24 meeting.
- 2.2 The Group urged States and all the stakeholders to enhance their cooperation and their support to the implementation of actions to enable the completion of the outstanding Conclusions and Decisions. Furthermore, the meeting requested the Secretariat to update target dates for all APIRG/24 Conclusions and Decisions that had exceeded the agreed timelines.
- 2.3 All the outcomes of the IIM/SG5 meeting were reviewed by the APIRG/25 meeting which adopt some Conclusions and Decisions. The status of implementation of these Conclusions and Decisions in the MET, CNS and AIM areas is provided in **Appendix A** to this Paper.
