1. Introduction

- 1.1 The APIRG Procedural Handbook requires the Group to review its outstanding Conclusions and Decisions in order to keep them current and their number at a minimum consistent with the progress achieved in implementation.
- 1.2 The AAOSG is tasked with among others to carry out comprehensive reviews and updates of all Conclusions and Decisions within the framework of APIRG that are applicable to the AAO Sub-Group in order to ensure continued relevance of the Conclusions and Decisions.

2. DISCUSSION

2.1 AFI and APIRG record their actions in form of Conclusions and Decisions as follows:

- (a) Conclusions deal with matters which, in accordance with the Group's Terms of Reference merit directly the attention of States, or on which further action is required to be initiated by the Secretary in accordance with established procedures.
- (b) Decisions relate to the internal working arrangements of the Groups and their subsidiary bodies.
- 2.2 During its deliberations, the APIRG/26 meeting recognized and appreciated the progress made so far in the coordination and conduct of AAO/SG activities, including the status of the implementation of Conclusions and Decisions relating to the AAO/SG. The meeting requested the subgroup to fastrack the implementation of the actions agreed upon in form of Conclusions and Decisions and called on States and Organizations to effectively carry out implementation of the same.
- 2.3 Notable improvement in the data collection and reporting has contributed to the updating of the status of implementation of the Conclusions and Decisions. There is still need for States and Organizations to enhance the pace of reporting in order to provide more current information.
- 2.4 The Status of implementation of the Conclusions and Decisions is presented in **Appendix 1** to this Working Paper.
