

WHY RWANDAIR VOLUNTEERED TO UPR&FRA PROJECT

RwandAir is continuously advancing to address the growing demands for improved fuel efficiency, lower emissions, and streamlined operations:

- The implementation of User Preferred Routes (UPR) and Free Route
 Airspace (FRA) is in line with these objectives.
- Additionally, UPR and FRA support the broader initiative for Africans to develop solutions to African challenges, reinforcing regional selfsufficiency and innovation.

BENEFITS OF UPR/FRA

- RwandAir Volunteered to join UPR/FRA on 25 July 2024
- RwandAir opted to start with the KGL-LOS flight due to the operational challenges of this flight: Crew Duty Time limitations
- RwandAir First UPR Trial Flight (KGL-LOS and VV) operated on 06 Sept
 2024
- 3 Consecutive Trial Flights operated 19-21 Sept 2024 (KGL-LOS and VV)

CHALLENGES

• Despite submitting ATC flight plans (FPLs) and UPRs before the flight, there is still a need for better coordination with ATC. Sometimes, ATC clears flights on a different route than initially submitted, which affects the efficiency of UPRs.

- Flight crew have reported potential drone threats on the KNM DCT IBNIN DCT OVPAP route.
- As a result. all RwandAir flights to West Africa and Europe are being rerouted via EGREK, increasing the flight distance.

ONGOING INITIATIVES WITH UPR/FRA

- RwandAir respectfully requests a 7-day trial for the KGL-LOS route
- RwandAir is submitting a request for a second route, KGL-LHR, involving several African ANSPs, including Uganda, DRC, Congo BZV, Tchad, Niger, and Algeria.
- Additionally, RwandAir intends to expand its UPR/FRA implementation
 with the following proposed city pairs running in parallel: KGL-BRU,
 KGL-ACC, and KGL-ABV.
