I wish to invite your Administration/Organization to the AFI Regional Safety Oversight Organizations (RSOO) Strategy follow-up Study Validation workshop, to be held in Kampala, Uganda, from 28 to 30 of April 2025, sponsored by The European Union Aviation Safety Agency (EASA) through the EU-Africa Safety in Aviation (EU-ASA) project.

Indeed, the 2017 Ezulwini Ministerial Declaration called for a study to strengthen RSOOs in the AFI region. In response, the AFI Plan developed a strategy and roadmap for enhancing the role and effectiveness of RSOOs in Africa. The recommendations were presented to the 25<sup>th</sup> AFI Plan Steering Committee Session, which proposed a high-level forum to establish a common understanding for implementing the AFI RSOO Strategic Plan.

The Second Global RSOO Forum held in October 2023 in Nairobi, Kenya, further examined ways to harmonize and ensure RSOOs sustainability. As a result, an in-depth feasibility analysis was recommended to refine the RSOO Strategy and Roadmap, focusing on funding mechanisms and optimizing the number and size of RSOOs. The 10th AFI RASG Meeting held in November 2024 in South Africa, provided an update on this study and encouraged stakeholder participation in the upcoming validation workshop.

To facilitate the necessary planning and preparatory activities, it would be appreciated if you could kindly confirm the participation of your State/Organization by registering online at https://www.icao.int/ESAF/Pages/validation-rsoo-raio-afi-2025.aspx at your earliest convenience and preferably not later than 4 April 2025.
