**AERODROMES EMERGENCY PLANNING IN THE MID REGION**

**1. INTRODUCTION**

1.1 The Aerodrome Emergency Plan is an essential part of the certification process requirement.

1.2 Most of MID States have created Aerodrome Authorities/Companies or other governmental entities to manage and operate their aerodromes, however, it is recognized that the role of States to ensure safety remains unchanged in accordance with the Chicago Convention and ICAO SARPs.

**2. DISCUSSION**

2.1 The meeting may wish to recall that MIDANPIRG/1 meeting was of the view that there is a need to provide more detailed information on the status of implementation of Aerodromes Emergency Planning and Safety Management System at each State's International Aerodrome listed in the MID Basic Air Navigation Plan (Doc 9708) and that a regular follow up of the status of implementation is to be carried out.

2.2 The meeting may wish to recall also that MIDANPIRG/12 Meeting agreed on Action Plan template as contained at **Appendix A** to this working paper and agreed on the following Decision:

*DECISION 12/6: SURVEY ON AERODROME EMERGENCY PLAN AND  
EMERGENCY OPERATION CENTRE*

*That,*

- a) a survey on Aerodrome Emergency Plan and Emergency Operation Centre be conducted in the MID Region; and*
- b) the result of the survey be analyzed by ICAO MID Regional Office and presented to AOP SG/8 for further course of actions as appropriate.*

2.3 MIDAPIRG/13 Meeting (Abu Dhabi, 22-26 April 2012), noted that as a follow-up action to the above-mentioned Decision, the ICAO MID Regional Office issued on 02 November 2011 a State Letter requesting States to complete the questionnaire on the subject. The meeting noted with concern that only four States (Jordan, Qatar, Saudi Arabia and UAE) provided the required information. Accordingly, the meeting agreed that States, that have not yet done so, should provide the required data to the ICAO MID Regional Office before 31 August 2012 for review and necessary action by the ADCI TF.

2.4 ICAO MID Regional Office issued State Letter (Ref. ME 3/56.16- 12/258 dated 30 August) asking MID State to respond to a survey of Status of Implementation of Aerodrome Certification Safety Management System (SMS), and Aerodrome Emergency Plan and Operation Center (EOC). Six States (Egypt, Iran, Jordan, Oman, Qatar, and UAE) have responded and provided their latest updates.

2.5 Based on the latest feedback provided by States, the SMS Implementation table has been prepared as contained in **Appendix A** to this working paper. The table shows that 24 of the MID States international aerodromes have implemented SMS. This number represents 40% of the international aerodromes to be listed in the ANP.

### **3. ACTION BY THE MEETING**

3.1 The meeting is invited to:

- a) note the information provided on this working paper; and
- b) keep the ICAO MID Office updated for any development in the area of Aerodrome Emergency Planning (AEP) and Emergency Operation Center (EOC).
