1. Introduction

1.1 MIDANPIRG/14, through Decision 14/24, agreed that the development of the MID eANP based on the Council-approved ANP Template, be included in the work programme of the different MIDANPIRG subsidiary bodies and the relevant Parts of the MID eANP be presented, as soon as available, to MSG/4 and/or MIDANPIRG/15 for endorsement.

2. DISCUSSION

- 2.1 The meeting may wish to note that, as a follow-up action to the MIDANPIRG/14 Decision 14/24, the concerned MIDANPIRG Subsidary Bodies (AIM SG/1, ATM SG/1, CNS SG/6, MET SG/5 and MSG/4) reviewed and updated the parts of the MID eANP related to their Terms of Reference, as follows:
 - a) the AIM SG/1 meeting (Cairo, Egypt, 6-8 May 2014) reviewed and updated the MID eANP parts of Volume I and II related to AIM and the proposed Tables for Volume III, Part II, B0-DATM and urged States to review the MID eANP draft templates/tables and provide their comments/inputs to the ICAO MID Regional Office by 31 July 2014 for final review by the ANP WG/2 meeting.
 - b) the ATM SG/1 meeting (Cairo, Egypt, 9-12 June 2014) reviewed and updated the MID eANP parts related to ATM and SAR and urged States to provide the ICAO MID Regional Office with their inputs and comments for the population of the different ATM Tables by 30 August 2014, for the presentation of a consolidated version of the MID eANP Parts related to ATM and SAR to the ANP WG/2 meeting.

- c) the CNS SG/6 meeting (Tehran, Iran, 9-11 September 2014) reviewed and updated the MID eANP parts related to CNS and urged States to provide the ICAO MID Regional Office with their inputs and comments for the population of the different CNS Tables by 15 October 2014, for the presentation of a consolidated version of the MID eANP Parts related to CNS to the MSG/4 and ANP WG/2 meetings.
- d) the MET SG/5 meeting (Jeddah, Saudi Arabia, 2 4 September 2014) agreed that the Secretariat populate the MID eANP as a matter of urgency for review by States in time for the MSG/4 meeting.
- 2.2 Based on the above, the MSG/4 meeting (Cairo, Egypt, 24-26 November 2014) reviewed the Draft version of the MID eANP VOL I, II and III, consolidated by the Secretriat based on the Council approved Template and the outcomes of the different MIDANPIRG subsidiary bodies (AIM SG/1, ATM SG/1, CNS SG/6 and MET SG/5).
- 2.3 The meeting may wish to note that, MSG/4 supported the work done by the Secretariat and different MIDANPIRG subsidiary bodies related to the development of the MID eANP and urged States to provide comments/updates to the MID eANP VOL I, II and III to the ANP WG/2 meeting, for the consolidation of the final version of the MID eANP for endorsement by MIDANPIRG/15. Accordingly, the MSG/4 meeting agreed to the following MSG Conclusion:

MSG CONCLUSION 4/4: DEVELOPMENT OF THE MID eANP

That,

- a) the ANP WG/2 finalize the MID eANP for endorsement by MIDANPIRG/15; and
- b) States be urged to review the MID eANP Volumes I, II and III available on the ICAO MID website, and provide updates/inputs to the ANP WG/2 meeting.
