
3.1 The meeting is invited to:

**MID REGION AIS DATABASE STUDY GROUP TASK FORCE (MIDAD STGTF)**

**1. TERMS OF REFERENCE**

The terms of Reference of the MIDAD STGTF are to:

- a) carry out necessary coordination with States for the establishment of the MID Region AIS Database (MIDAD);
- ~~b) monitor the development of the MIDAD initial Study/Business case;~~
- c) monitor the developments and establishment of the MIDAD Project detailed MIDAD study addressing all technical, operational, financial, human, legal and institutional issues, and provide necessary guidance;
- ~~d) develop the Call for Tender for the establishment of MIDAD;~~
- ~~e) negotiate the contract for the establishment of MIDAD with the chosen Contractor (MIDAD Service Provider); and~~
- f) agree on the mechanism for the monitoring of MIDAD operations and maintenance;
- g) provide regular progress reports to the AIM SG, ANSIG and MIDANPIRG, as appropriate, concerning its work programme; and
- h) review periodically its Terms of Reference and propose amendments, as necessary.

**2. COMPOSITION**

The MIDAD STGTF is composed of:

- a) all MID States; and
- b) concerned International/Regional Organizations as observers.
  - i) Other representatives from industry and user Organizations having a vested interest in Aeronautical Information Management and experience in the development of Regional AIS Databases could participate as observers, as necessary.
