SUMMARY

The aim of this paper is to agree on the Provisional Agenda for the MIDANPIRG/15 meeting as well as the tentative dates and venue of the MSG/5 meeting.

1. INTRODUCTION

1.1 In accordance with the MIDANPIRG Procedural Handbook, the MIDANPIRG Steering Group (MSG) is expected to review and update, as necessary, its Terms of Reference and to decide on the dates and venue of its next meeting.

2. DISCUSSION

2.1 In accordance with its Terms of Reference (ToRs), the MSG should execute a pivotal function as a coordinating and steering organ with highest possible efficiency in accordance with the goals set by MIDANPIRG. It should inter-alia, direct the work of the MIDANPIRG subsidiary bodies in the best manner, commensurate with the overall MIDANPIRG work programme, with clearly defined tasks, deliverables and target dates.

2.2 MIDANPIRG/15 is planned to be held in Bahrain, 8-11 June 2015. The Provisional Agenda at **Appendix A** is presented for review and comment by the meeting.

2.3 The ICAO MID Office received a formal request from Iran to host the MSG/5 meeting. Accordingly, it's proposed that the MSG/5 meeting be held in Iran (exact venue to be defined) during the second quarter of 2016.
