



The BLUE MED FAB Implementation Programme: PBN

- Elaboration of a BLUE MED PBN implementation policy
- Elaboration of a BLUE MED FAB roadmap

✓ First phase

- Approach Procedures with vertical guidance (target:2016 within BM FAB)
- Updated airport list maintained at Interim Deployment Programme level

✓ Second phase

- Harmonization plan (including analysis of next PBN IR)
- Overall FAB reporting provided to EC under the Interim Deployment Steering Group framework
- Elaboration of ICAO conformity guidelines

PBN wayforward

BLUEMED has already proved capabilities based on the experience gained by some member States on PBN implementation.

- Further opportunities:
 - **Support to local PBN implementation plans definitions**
 - **Sharing of experience**
 - **Training capabilities**
 - **Independent procedure reviews among States members**
 - **Investigation of EU funding availability for specific activities**
- Coordination and efficient use of stakeholders capabilities (States, ICAO, Eurocontrol and BLUEMED) for PBN implementation



Joining the BLUE MED FAB PBN Implementation roadmap

- Bilateral agreement/MoU between the local CAA/ANSP and the BLUE MED Organisational arrangement concerned
- Definition of local PBN targets and identification of potential PBN initiatives
- Joint definition of the local PBN deployment roadmap and its Incorporation within the overall BLUE MED PBN Implementation roadmap
