**MID REGION AIM DATABASE TASK FORCE (MIDAD TF)**

**1. TERMS OF REFERENCE**

The terms of Reference of the MIDAD TF are to:

- a) take responsibility for overall leadership, supervision, direction, and management of the MIDAD project, in coordination with the MAEP PMO/SC/Board;
- b) carry out necessary coordination with States for the establishment of the MID Region AIM Database (MIDAD);
- c) address all technical, operational, and financial, ~~legal and institutional~~ issues related to MIDAD;
- d) address legal and institutional issues related to MIDAD, in coordination with the MAEP PMO/SC/Board;
- e) agree on the mechanism(s) for the oversight of MIDAD;
- f) monitor the developments of the MIDAD Project; and
- g) provide regular progress reports to the AIM SG, MAEP SC/Board, MSG, ANSIG, and MIDANPIRG and DGCA-MID, as appropriate, concerning its work programme.

**2. COMPOSITION**

The MIDAD TF is composed of:

- a) all MIDAD member States;
- b) other MID States which are not member of MIDAD and concerned International/Regional Organizations, as observers; and
- c) representatives from industry and user Organizations having a vested interest in Aeronautical Information Management and experience in the development of Regional AIS/AIM Databases could participate as observers, as necessary.
