Strengthen ICAO/WHO Collaboration



- ICAO/WHO letter of agreement (or similar)
 - Establish common Public Health and aviation/CAPSCA agenda (CAPSCA/WHO events)
 - Multisectoral pool of experts for WHO airport certification
 - Coordinated information sharing during public health emergencies (Zika outbreak)
 - Develop joint WHO/ICAO training initiatives (CAPSCA-EUR)
 - Joint fundraising
 - goals, success indicators, ? value added from CAPSCA.

- *ICAO No Country Left Behind*
 - assistance to developing States: States to pool resources on regional basis, fundraising; build capacity
- Improved information gathering and sharing (WHO evaluations, CAPSCA evaluations, implementation of measures during a PHEIC)
- Disinfection, disinsection, management of on board cases

Regional issues



- Improved ICAO/WHO regional offices collaboration
- Ebola Aviation Action Plan 2015-16
- Joint WHO/ICAO meetings



National/operational issues

- Improved public health and aviation collaboration
- Improved risk assessment
- USOAP audit questions improved/developed
- States to join CAPSCA; AVs to all States (action plans, follow up, stakeholder agreements)
- Implementation of CAPSCA concepts throughout national aviation system (not only major airport(s))
- Advocacy for CAPSCA at WHO and ICAO global and regional meetings.
