1. INTRODUCTION

1.1 The meeting may wish to recall that Sudan replied to the ICAO MID Office Letter REF.: AN 6/33-16/023 dated 26 January 2016, indicating its willingness to support and host the MID FPP.

2. DISCUSSION

2.1 The meeting may wish to note that Sudan presented the hosting offer of the MID FPP to the PBN SG/2 meeting, held in Sharm El Sheikh, 22-25 February 2016. The PBN SG/2 meeting appreciated Sudan offer and requested that the offer be presented to the MAEP Board/2 meeting for final decision.

2.2 The offer was sent to the ICAO MID Office through Letter 2016/23 dated 17 March 2016. Sudan is keen to provide all the necessary facilities, equipment and support to ensure the success of the MID FPP.

Sudan MID FPP Hosting Offer

1. Sudan is offering to provide the following:
 - Suitable office space and furniture including maintenance and repairs.
 - Computer equipment and Information Technology equipment.
 - Procedure design and charting equipment.
 - Suitably equipped classroom(s) for MID FPP training courses.
 - One car for the MID FPP Coordinator.
 - Operating and maintenance expenses as related to the office facility, including, electricity, water, internet connection, local and international phone connections, cleaning, office security, etc.
 - SCAA will facilitate the issuances of visas, accreditations or residence permits for the ICAO experts and recognized dependents ensuring the expeditious relocation of them at the duty station and for the whole duration of their ICAO contracts and subsequent renewals.
 - SCAA will facilitate the issuances of entry visas for experts visiting or attending courses at the MID FPP premises.
