1. INTRODUCTION

1.1 The meeting may wish to recall that, in order to improve the timeliness of aeronautical information and in accordance with the ICAO Guidelines on the use of Public Internet for Aeronautical Applications (Doc 9855), the MIDANPIRG/11 meeting, through Conclusion 11/39, encouraged States to use the internet for the advance publication of the Aeronautical Information Products.

2. DISCUSSION

- 2.1 In accordance with the ICAO Annex 15, "Each Contracting State shall ensure that the aeronautical data and aeronautical information provided are complete, timely and of required quality in accordance with 3.3."
- 2.2 Issues/delays in mail/postal system is usually out of AISPs' control. Considering the importance of timeliness of aeronautical information for the Users, in particular AIRAC amendments, relying on hardcopy and mail system would not ensure that the States' AIS products are received, processed and used by the Users in a timely manner. AIS websites are currently the main resource of users, in particular for DAT providers, to get access to States' aeronautical information.
- 2.3 11 (out of 15) MID States have developed websites for AIS. However, only 8 States provide their AIP, 7 States AIP amendments and 6 States NOTAL Lists on the web, as reflected in the following table:
