PASSPORT/VISA

- 8.1 All foreign nationals entering Sudan must possess valid passports for six months.
- 8.2 Visa should be obtained from the Sudanese Embassy or Consulate in the Country of Origin/Residence prior to departure for Sudan, e-visa can be applied through invitation letter.

CUSTOMS

- 8.4 The following items are not allowed to be brought into Sudan:
 - Alcohol Drinks

Additional quantities of the above items may also be purchased from the Airport duty free shop after clearing customs.

9. CURRENCY, CREDIT CARDS AND BANKING SERVICES

- 9.1 The unit of currency in Sudan is the POUND. Current rate of exchange for US \$ is US \$ 1 = 15.87SP approximately (not fixed).
- 9.2 The foreign currency more than 10000 US \$ should be declared.
- 9.3 International Credit Cards, such as American Express, Diners Club, Visa, Master Charge, Carte Blanche, etc. are not accepted.
- 9.4 All commercial banks exchange major foreign currencies and are open from 0900 to 1800 hours Sundays through Thursdays.
- 9.5 Some commercial banks exchange major foreign currencies and are open from 08:30 to 03:00 pm.

10. OTHER USEFUL INFORMATION

SHOPPING

10.1 Shopping areas are available in Sudan. Be prepared to bargain in small shops, sidewalk vendors etc. In large stores the prices are fixed.

TAP WATER

10.2 It is recommended that all visitors drink bottled water/beverages.

11. WEATHER CONDITIONS

11.1 The main daily minimum and maximum temperatures for the month of February in Sudan are between 22°C and 27°C.
