MIDANPIRG/16 CONCLUSIONS AND DECISIONS RELEVANT TO THE MET FIELD

SUMMARY

This paper provides the status of MIDANPIRG/16 Conclusions and Decisions relevant to the MET field.

Action by the meeting is at paragraph 3.

1. Introduction

1.1 The meeting will recall that MIDANPIRG/16 (13-16 February 2017, Kuwait) adopted 3 Conclusions that were related to the MET field and 6 Conclusions that were at least partly related to the MET field. A status and action plan of these Conclusions and Decisions is provided at **AppendixA** to this working paper.

2. DISCUSSION

- 2.1 With reference to MIDANPIRG Conclusion 16/3, MID Region Air Navigation Strategy, it was endorsed and published as MID Doc 002. In addition, MIDANPIRG Conclusion 16/7, the MID Region Air Navigation Report 2016 was endorsed and can be found at https://www.icao.int/MID/Pages/default.aspx. Furthermore, MIDANPIRG Conclusion 16/8 urged MID States to develop/update their National ASBU Implementation Plan, ensuring the alignment with and support to the MID Region Air Navigation Strategy (MID Doc 002) and provide the ICAO MID Office with relevant data necessary for the development of the MID Region Air Navigation Report-2017, by 1 November 2017.
- 2.2 With reference to MIDANPIRG Conclusion 16/4, the amendment to the MID eANP Volume III was approved by MIDANPIRG/16 and notification of amendment issued on 18 June 2017.
- 2.3 With reference to MIDANPIRG 16/12, States, organizations and industry were invited (SL Ref.: AN 8/28.1-17/175 dated 14 June 2017) to actively participate in the Interregional Seminar on "Service Improvement through Integration of Digital AIM, MET and ATM Information Services" that will be held in Brussels, Belgium from 2 to 4 October 2017.

- 2.4 Of interest to ICAO Meteorological Information Exchange Model (IWXXM) implementation, MIDANPIRG Conclusion 16/24 endorsed the First Edition of File Transfer Body Part (FTBP) Testing Document at Appendix 5.2.2N of the MIDANPIRG/16 Report.
- 2.5 With reference to MIDANPIRG Conclusion 16/27, States were invited (Ref.: AN 10/16 17/208 dated 1 August 2017) and encouraged to participate in the EUR Special Air-Report Test in order to identify deficiencies and associated solutions in the reporting and dissemination of these reports. Results will be addressed in WP/3.
- 2.6 With reference to MIDANPIRG Conclusion 16/28, the MID Regional SIGMET Guide was endorsed and published as ICAO MID Doc 009 and contains updates related to Amendment 77 to Annex 3.
- 2.7 Lastly, with reference to MIDANPIRG Conclusion 16/29, the proposal for amendment to the MID ANP Volumes I and II is being coordinate with ICAO Head Quarters since some elements (e.g. references to SADIS) require coordination since other ANPs in other Regions would also be impacted.
