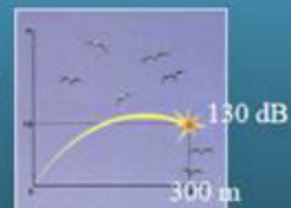

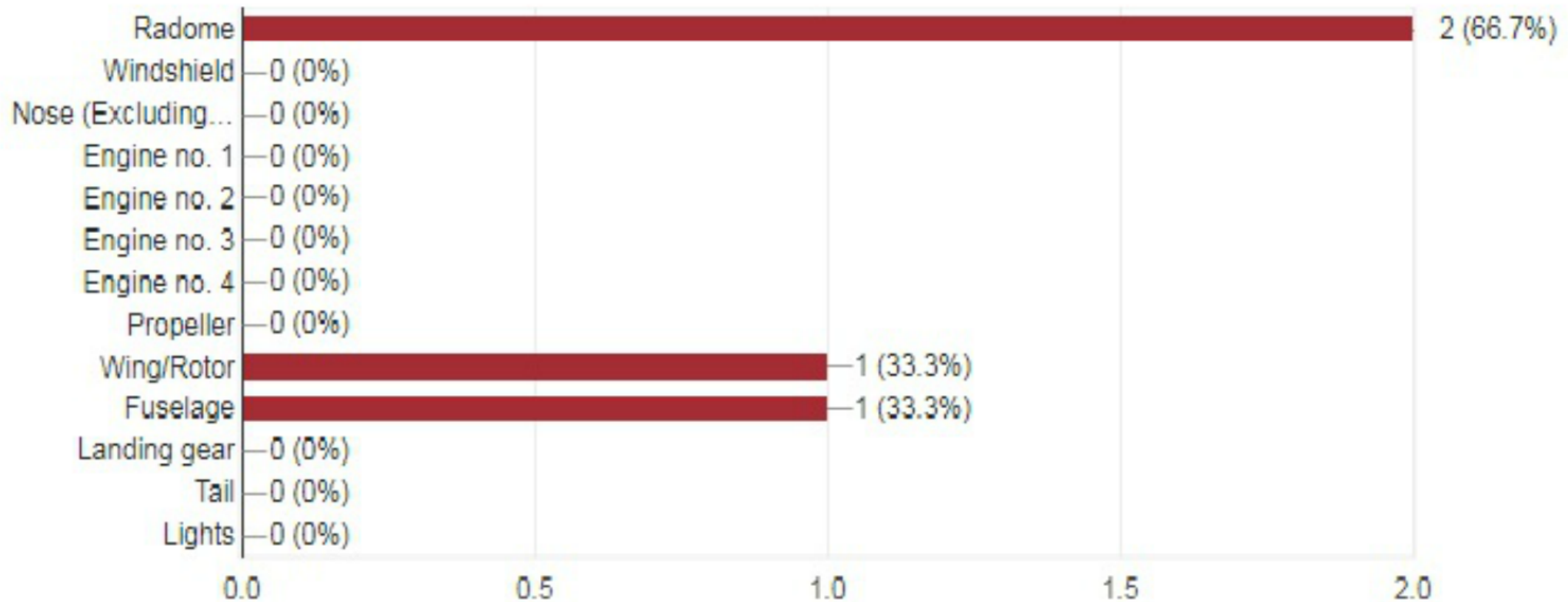

Parts of Aircraft Damaged

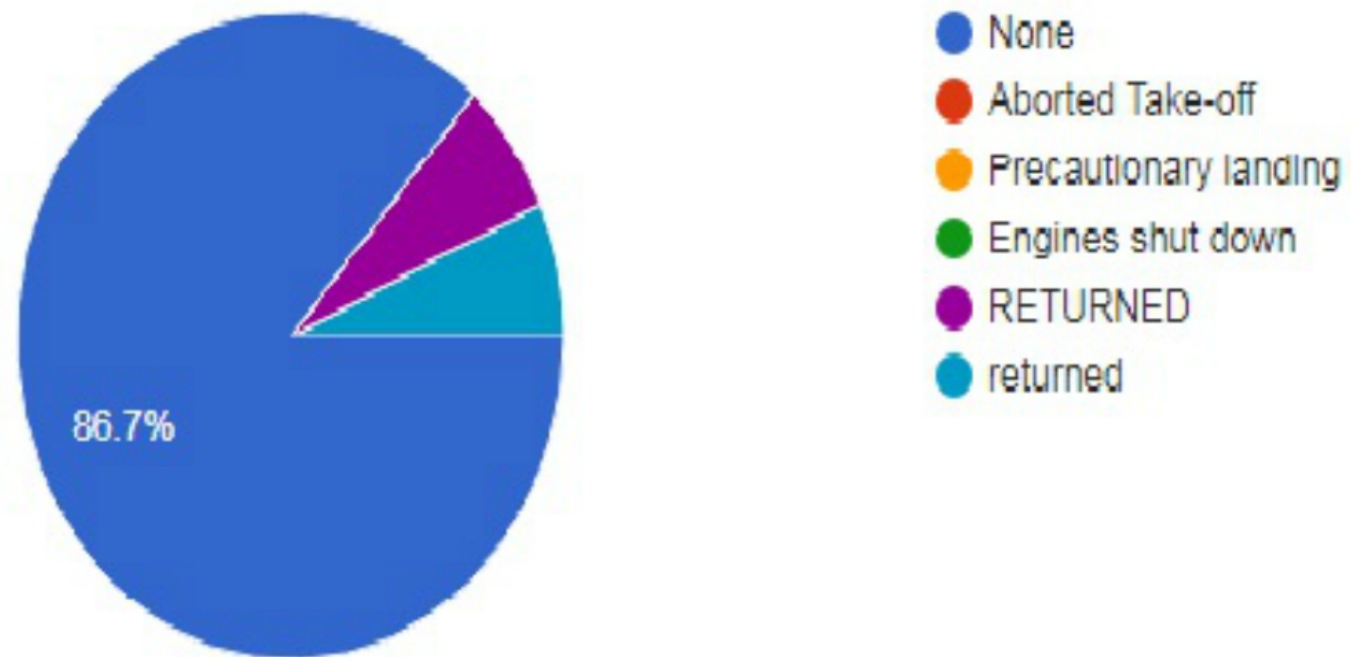
