#### 1. LOCATION

1.1 The Sixth meeting of the Regional Aviation Safety Group – Middle East (RASG-MID/6) will be held in Movenpick Hotel, Bahrain, from 26 to 28 September 2017. The meeting will be gratefully hosted by Civil Aviation Affairs (CAA) of Bahrain.

#### 2. SCHEDULE OF THE MEETING

- 2.1 The opening session of the meeting will be held at 0900 hours on Tuesday 26 September 2017.
- 2.2 The schedule and order of the day will be announced at the Opening session.
- 2.3 The meeting will be conducted in English.

#### 3. REGISTRATION OF PARTICIPANTS

3.1 Participants are requested to register, at the Registration Desk located at the entrance of the designated conference room, between 0800 and 0900 hours on the opening day of the meeting. Participants are also requested to wear the Identification Badge which will be issued to them during registration.

### 6. TRANSPORTATION

- 6.1 Participants are requested to make their own arrangements for transportation from the airport to the city and return; some hotels offer airport transfers.
- 6.2 Airport Taxi Services operate from the Airport to Bahrain downtown is approx. BD 5 per vehicle

#### 7. Insurance

7.1 Participants are advised to have insurance coverage for any unexpected contingency including transport hazards (taxi, buses, rented cars, etc.) and Medical Coverage.

#### 8. SOME USEFUL TRAVEL INFORMATION

#### PASSPORT/VISA

- 8.1 All foreign nationals entering Bahrain must possess valid passports for six months.
- 8.2 Visa, when needed, should be obtained from the Bahraini's Embassy or Consulate in the Country of Origin/Residence prior to departure for Bahrain.
- 8.3 Visas can be applied on line through the website <a href="www.evisa.gov.bh">www.evisa.gov.bh</a> however for any additional assistance in the process of issuance of entry visa to Bahrain, copy of the Passports of delegates, may be sent, not later than 15<sup>th</sup> August 2017 to CAA Bahrain, to the attention of Mrs. Surbita D'souza Email: sdsouza@mtt.gov.bh.

### **CUSTOMS**

- 8.4 The following items are allowed to be brought into Bahrain:
  - Personal effects, such as necessary clothing
  - 200 cigarettes or 250 gr. of cigars or tobacco
  - Perfume for personal use

Additional quantities of the above items may also be purchased from the Airport duty free shop after clearing customs.

## 9. CURRENCY, CREDIT CARDS AND BANKING SERVICES

- 9.1 The unit of currency in Bahrain is the **Bahraini Dinar (BHD)**. Current rate of exchange for US \$ is US \$ 1 = 0.377 approximately.
- 9.2 There are no restrictions on import of foreign currency.
- 9.3 International Credit Cards, such as American Express, Diners Club, Visa, Master Charge, Carte Blanche, etc. are usually accepted at most hotels, department stores and restaurants.
- 9.4 All commercial banks exchange major foreign currencies and are open from 0800 to 1300 hours Sundays through Thursdays.

#### 10. OTHER USEFUL INFORMATION

### **SHOPPING**

10.1 Shopping areas are available in Bahrain. Be prepared to bargain in small shops, sidewalk vendors etc. In large stores, however, the prices are fixed.

### TAP WATER

10.2 It is recommended that all visitors drink only bottled water/beverages.

## 11. WEATHER CONDITIONS

11.1 The main daily minimum and maximum temperatures for the month of September in Bahrain are between 28°C to 32 °C.
