OUTCOME OF THE MID-SST/3 MEETING

MID-SST/3 Report

1. Introduction

- 1.1 The Third meeting of the MID Safety Support Team (MID-SST/3) was hosted by the General Civil Aviation Authority (GCAA), Abu Dhabi, UAE, 10-13 October 2016. The meeting was attended by eight (8) States (Iraq, Jordan, Kuwait, Oman, Qatar, Saudi Arabia, UAE and United States) and five (5) International Organizations/Industries (Boeing, CANSO, COSCAP-GS, GCC and IATA).
- 1.2 In accordance with the revised MID-SST Terms of Reference, the MID-SST shifted to a different way of doing business, where States and Partners share expertise, experience and best practices in order to provide recommended actions related to the implementation of the Safety Enhancement Initiatives (SEIs).
- 1.3 The MID-SST/3 meeting included a one day NCMCs meeting, to share and discuss all issues related to USOAP CMA, including the status, challenges and best practices. The NCMCs meeting will be part of the future MID-SST meetings.

2. DISCUSSION

- 2.1 Based on a Draft Decision emanating from the MID-SST/3 meeting, the RSC/5 meeting, through Decision 5/4, agreed to a revised set of SEIs, as follows:
 - 1- improve the status of implementation of State Safety Programme (SSP) and Safety Management System (SMS) in the MID Region;
 - 2- strengthening of States' Safety Oversight capabilities;
 - 3- improve Regional cooperation for the provision of Accident & Incident Investigation; and

- 4- improve implementation of ELP requirements in the MID Region.
- 2.2 With respect to the SSP/SMS implementation in the MID Region, the meeting:
 - a) identified common challenges/difficulties based on the States feedback related to SSP implementation including identification of a designated entity, establishment of an initial Acceptable Level of Safety Performance (ALoSP), allocation of resources to enable SSP implementation and lack of qualified and competent technical personnel; and
 - b) agreed to the following actions to support the SSP implementation:
 - participate in the new ICAO Safety Management Training Programme (SMTP);
 - work with the ICAO Regional Office to make use of available means (e.g. Technical Co-operation Bureau) to provide assistance needed for SSP implementation;
 - consider the establishment of a mechanism similar to the RS Go Team in order to conduct assistance missions to States to address specific needs (SSP/SMS,USOAP-CMA, etc.);
 - identify safety management best practices in coordination with States (champion State to promote best practices among other States) including sharing of technical guidance and tools related to SSP (e.g. advisory circulars, staff instructions);
 - continuous update of the SSP Gap Analysis and completion of detailed SSP Self-Assessment; and
 - establishment of voluntary and mandatory safety reporting systems.
- 2.3 With regard to SMS implementation at MID International Aerodromes, the RSC/5 meeting agreed that Saudi Arabia and Egypt work on a proposal for an action plan to be discussed in the RGS WG in order to be further processed by the MID-SST.
- 2.4 For the SMS implementation in ATM, CANSO as the Champion of the initiative will provide update in a separate WP.
- 2.5 The meeting recognized the need to monitor the status of SMS implementation by air operators, maintenance organizations and training organizations involved in flight training in order to take necessary actions to overcome the challenges faced and improve safety. In this regard, the meeting agreed that IATA with the support of the ICAO MID Office will provide feedback and a plan of actions to address SMS implementation by air operators.
- 2.6 The meeting agreed that the second SEI related to the strengthening of States' Safety Oversight capabilities should not be limited to the establishment of Regional/Sub-regional Safety Oversight Organizations(s) (RSOO).
- 2.7 With respect to the third SEI "improve Regional cooperation for the provision of Accident & Incident Investigation", the ACAC/ICAO AIG Workshop was hosted by Saudi Arabia in Jeddah, 25-27 April 2017, in order to address issues related to Accident and Incident Investigation, with a special focus on Regional Cooperation in order to finalize the Strategy for regional cooperation. The subject will be covered in a separate WP.

- 2.8 For the newly added SEI related to the implementation of ELP requirements in the MID Region, it was noted with appreciation that UAE will champion the proposed SEI and will develop a questionnaire, in coordination with the ICAO MID Office, to be used as the basis of a survey to assess the implementation of ELP requirements, and agree on the next course of actions.
- 2.9 The meeting may wish to note that the MID-SST/3 meeting developed a list of actions in support of the agreed SEIs as at **Appendix A**, which was supported by the RSC/5 meeting.

3. ACTION BY THE MEETING

- 3.1 The meeting is invited to:
 - a) note the progress made by the MID-SST and agree on the way forward; and
 - b) encourage States and stakeholders to support the MID-SST activities, including the list of actions at **Appendix A**.
