Background

Audit under the Comprehensive Systems Approach (CSA)

- Date: 21 to 30 of November 2006
- The audit generated: 87 Findings; with399 PQs found not satisfactory.
- Effective Implementation (EI): 49.3 %



Background (Cont.)

First ICVM to Sudan under the USOAP CMA:

- Date: 11 to 15 December 2011.
- ➤ 399 PQs were assessed (LEG, ORG, PEL, AIR, OPS,AIG, ANS and AGA); progress reviewed on 80 findings
- 158 PQs changed to satisfactory.
- 2 PQs changed to not applicable.
- 239 PQs remain not satisfactory.
- The effective implementation (EI) improved from 49.3 % to 68.9%.
- ➤ A potential SSC related to the air operator certification process were identified.



Background (Cont.)

Second (ICVM) to SUDAN under the USOAP CMA:

- Date: 16 to 19 May 2012.
- 32 PQs in the areas of OPS and AIR assessed.
- 26 PQs changed to satisfactory.
- The effective implementation (EI) improved from 68.9 % to 73.17% according to ICVM Report.
- According to ICAO SOA website EI is 74.56%



Background (Cont.)


Third USOAP CMA OFF-SITE VALIDATION

- Date: 6 to 15 October 2014.
- > 157 US/PQs in the areas of AIR, ANS and AGA assessed.
- 5 PQs changed to satisfactory.
- The effective implementation (EI) improved from 73.17 % to 73.81% according to the Report.
- According to ICAO SOA website El now is 74.56%.





Effective Implementation (EI) by Critical Element














Number of Protocol Questions (PQs) in LEG by Audit sub-group




 $_{\bigodot}$ Effective Implementation (EI) \bigcirc Lack of Effective Implementation (LEI)

Number of Protocol Questions (PQs) in ORG by Audit sub-group




Effective Implementation (EI) _ Lack of Effective Implementation (LEI)

Number of Protocol Questions (PQs) in PEL by Audit sub-group



Number of Protocol Questions (PQs) in OPS by Audit sub-group



Number of Protocol Questions (PQs) in AIR by Audit sub-group





Number of Protocol Questions (PQs) in AIG by Audit sub-group





Number of Protocol Questions (PQs) in ANS by Audit sub-group



Main obstacles

- Lack of Human Resources
- ➤ Not enough time is allocated for USOAP CMA activities
- Findings relate to other Government entities i.e. AIG, ANS (highest scores in unsatisfactory PQ's: ANS 122 & AIG 81)
- Amendment of the Law takes time (in the case of AIG)
- ➤ Due to relatively small scale of aviation activities, presenting evidence of effective implementation is sometimes difficult



Work Strategy

Important considerations:

- ➤ 187 PQ's remain unsatisfactory (not including the "new" PQ's)
- ➤ The work programs to complete the CAP and PQ's are integrated rather than separated
- ➤ With the exception of one, all implementation dates are overdue.



Work programme to complete CAP and PQ's

- The plan is to have the CAP and PQ's fully implemented and addressed BY THE END OF 2018.
- Each Corrective Action will be linked to the applicable PQ and addressed at the same time.
