Historical Background

A new Strategy was requested by the ACAC/ICAO AIG Workshop
(Jeddah 25-27 April 2017)

Accordingly, an Ad-Hoc Working Group was formed



The New Strategy

Modified version

Three Levels of States

Movement from one Level to the next depends on the willingness of the State and its performance

States to maintain a minimum of Level 2

The Old Strategy


Difficult to implement

Required the States to collectively move from one phase to the next

Insufficient consideration given to variations across States' capabilities

Roadmap

- A Roadmap for the implementation of the Strategy was developed under the framework of RASG-MID.
- The Roadmap provides details for implementation of the different Levels by main action points.
- KPIs to monitor implementation were set.
- Decisions are to be taken based on achievement goals, after States discussion/evaluation.


Level 1- Bilateral Agreements

- The RASG-MID/6 Meeting:
 - ✓ Supported the new Strategy for final endorsement by the DGCA-MID/4 Meeting; and
 - ✓ Recommended to further finalize/revise the draft Roadmap.



DGCA-MID/4 Meeting

- Endorsed the Strategy; and
- Agreed with the RASG-MID/6 Meeting recommendation to further finalize/revise the Roadmap.



SST/4 Meeting

- The SST/4 Meeting is invited to support RASG (MID and North Africa), and to:
 - ✓ Discuss the draft Roadmap
 - ✓ Form a Working Group to amend the draft Roadmap, and submit it to the SST Rapporteur.
- The Working Group may draft a State Letter inviting MENA States to designate official focal point(s) as members of the Roadmap AIG TF.
- The AIG TF will follow up the implementation of the Strategy.
