Minutes of the MID Region Flight Procedure Programme (MID FPP) Coordination Meeting (Aqaba, Jordan, 4-5 December 2019)

- 1. The MID FPP Coordination was held in Aqaba, Jordan on 4 and 5 December 2019, back-to-back with the ATM SG/5 meeting.
- 2. The meeting was attended by twenty six (26) participants from Bahrain, Egypt, Iraq, Jordan, Oman, Qatar, Saudi Arabia, UAE, IATA and ICAO. The list of participants is at **Attachment A**. The meeting was moderated by Elie El Khoury from ICAO.
- 3. The meeting was apprised of the outcome of the DGCA-MID/5 meeting (Kuwait, 4-6 November 2019) related to MID FPP, in particular, the change of hosting of the MID FPP to Abu Dhabi, UAE and the signature of the MID FPP ProDoc by 6 States. The meeting noted that ICAO will provide the funds to cover the expenses of the manager at least for the first year.
- 4. An overview of the MID FPP institutional and managerial framework was presented with highlights on details in the MID FPP ProDoc including the vision on how the MID FPP services will be provided.
- 5. It was highlighted that the MID FPP ProDoc is awaiting the ICAO Secretary General signature. It was underlined that currently only Kuwait and UAE signed as Active States. Accordingly, ICAO is coordinating closely with other States to sign as Active States in order to ensure the sustainability of the Programme after the first year.
- 6. The meeting received a presentation form UAE providing an update on the hosting arrangements for the MID FPP Office. The meeting noted with appreciation that the UAE (the Host State) will designate a coordinator, until the recruitment of the MID FPP Manager, to implement some tasks to facilitate the launching and execution of the Work Plan of 2020.
- 7. The meeting developed a draft Work Plan for 2020 focusing mainly on training. The details and exact dates will be coordinated with UAE and presented to the First meeting of the MID FPP Steering Committee (MID FPP SC/1, Abu Dhabi, UAE, 18-20 February 2020).
- 8. The meeting discussed options for the funding mechanism of the Programme and agreed that due to the absence of 4 States out of 6 that signed the ProDoc no decision should be taken and the discussion should be differed to the MID FPP SC/1 meeting.
- 9. The meeting noted that ICAO will send out the invitation of the MID FPP SC/1 meeting to the States that signed the ProDoc as well as the other States to encourage the joining of the Programme. Another State Letter will be circulated to all MID States and Organizations by MID Office calling for the nomination for candidates to be part of the MID FPP pool of experts. The Letter should highlight the criteria to be applied for the selection of candidates and how they are expected to perform their tasks in the future.
- 10. Participants were encouraged to follow-up with their authorities for the signature of MID FPP ProDoc as Active States and participation in the MID FPP SC/1 meeting.
