

CART Recommendations

Aviation Safety-related Measures

- **Recommendation 1**: During the global COVID-19 outbreak, Member States should continue updating COVID-19 Contingency Related Differences (**CCRDs**) in the Electronic Filing of Differences (EFOD) subsystem.
- Recommendation 2: Member States should avoid retaining any COVID-19 related alleviation measures as soon as normal operations are resumed. Differences that remain after the contingency if any should be filed in the EFOD system.
- **Recommendation 3**: Member States should expedite the development of **guidance for safety management** of new operations or operation change during this crisis.

Aviation Public Health-related Measures

- Recommendation 4: Global and regional harmonization of procedures is essential to strengthen public and passenger confidence in air travel. To that end, Member States should establish aviation public health procedures aligned with the guidance in the Take-off: Guidance for Air Travel through the COVID-19 Public Health Crisis.
- Recommendation 5: In order to support the fastest possible return to normal aviation operations, Member States should regularly review the necessity of continuing the application of risk mitigation measures as the risk of COVID-19 transmission diminishes; and measures which are no longer needed should be discontinued.



CART Recommendations

Security and Facilitation-related Measures

- Recommendation 6: Member States that have not done so should immediately establish a National Air Transport Facilitation Committee (or equivalent) as required by Annex 9 to increase national level cross-sectoral coordination.
- Recommendation 7: Member States should systematically use a Passenger Health Locator Form to ensure identification and traceability of passengers to help limit the spread of the disease and resurgence of the pandemic.
- Recommendation 8: While temporarily adapting their security-related measures, using the guidance provided, Member States should strengthen their oversight system to ensure these measures are consistently applied with the objective of protecting aviation against acts of unlawful interference.
- Recommendation 9: Member States should take measures to ensure that relevant personnel are provided training to identify and manage unruly passenger situations related to non-respect of essential aviation public health and safety measures.

Economic and Financial Measures

• Recommendation 10: Member States should consider appropriate extraordinary emergency measures to support financial viability and to maintain an adequate level of safe, secure and efficient operations, which should be inclusive, targeted, proportionate, transparent, temporary and consistent with ICAO's policies, while striking an appropriate balance among the respective interests without prejudice to fair competition and compromising safety, security and environmental performance.

Regular monitoring and sharing of experiences through ICAO

• Recommendation 11: Member States should facilitate information-sharing and exchange on their actions and best practices by contributing to an ICAO database of measures.



Information Sharing- MID States Measures & Guidelines



In order to prevent and control the spread of COVID-19, the ICAO MID Office urge States to act in accordance with the relevant standards contained within the various Annexes to the Convention on International Civil Aviation (Chicago Convention).

States shall adhere with the provisions of the related ICAO Annex 9 - Facilitation provisions to expediting the release and clearance of goods carried by air in order to ensure the sustainability of the global air cargo supply chain and maintain the availability of medication, and equipment such as ventilators, masks and other health and hygiene related goods, which are necessary to assist in reducing the public health risk of the spread of COVID-19. In this regard, ICAO has developed a COVID-19. To spublic website.

States are requested to provide ICAO with the actions taken to reduce the spread of the COVID-19 by air transport aiming at protecting the health of air travelers and the aviation personnel in accordance with the ICAO Annex 11 provisions.

As there is urgent need to reduce the risks of the spread of COVID-19 by air transport and to protect the health of air travelers and aviation personnel, contingency arrangements should be provided, as necessary, as it is incumbent upon the air navigation services provider (ANSP) to ensure that information on exceptions are detailed in the subsequent promulgation of NOTAM. Contingency arrangements should consider potential reduction of staffing across air navigation services personnel, particularly, centres providing ATS and aerodrome services.

States are urged to inform ICAO of any temporary differences that may arise from COVID-19 contingency measures, particularly those related to licensing and certification. States should also indicate, in general terms, whether the State will recognize or accept the validity of certificates and licenses affected by the special temporary measures of other States. The aforementioned information can be provided by the National Continuous Monitoring Coordinator (NCMC) or any other authorized user:

- · via the CCRD sub-system accessible through the EFODs dashboard; or
- by sending an off-line CCRD form available on the ICAO COVID-19 Operational Safety Measures public website by email to ops@icao.int

Guidance on how to submit the information is provided on the I<u>CAO COVID-19 Operational Safety Measures public website</u>. States are also encouraged to share with ICAO any information on the measures taken during this period providing links when possible. This information should be sent to ops@licao.int , All information, including CCDP reports, will be made available on the ICAO COVID-19 OPS public website.



MID RPTF Framework

Effective implementation of the Collaborative Arrangement for the Prevention and Management of Public Health Events in Civil Aviation (CAPSCA) Programme in the MID Region amid COVID-19 crisis

11 MID States completed the CAPSCA Survey

ICAO-MID established platform to centralize and communicate all guidance materials to the States and stakeholders

All GM & States' best practices are continuously communicated to States and other stakeholders.

MID Recovery Plan Task Force (RPTF) Platform

The COVID-19 pandemic has caused significant and unprecedented challenges to the aviation sector, shutting down all commercial international passenger operations. The High-Level MID Regional Meetings/Teleconferences between ICAO, AACO, ACAO and IATA on COVID-19 Crisis Management agreed to establish the MID Region Recovery Plan Task Force (RPTF).

The main objective of the RPTF is to monitor global restart and recovery developments and ensure the harmonization, and where necessary regional customization, of the implementation of these global developments at the Regional level. In addition, the RPTF plays an advisory role to the MID states, assisting in the formulation of regional restart and recovery plans, and implementing regional activities in support of its objectives, taking into consideration the work done at the global level in order to ensure alignment and avoid duplication of efforts.

The RPTF established 4 technical work streams namely: Public Health Requirements, Operational Safety Measures, Airport & Passengers Facilitation, and Air Navigation Services/Air Traffic Management.

Each stream includes the guidance material developed at the global level mainly by ICAO and IATA to support States during the restart and recovery phases. Moreover, each stream contains the progress reports completed and finalized by the RPTF and other documents as deemed necessary.

The Guidance Material (GM) have been grouped by organizations and are presented in tabular format as individual PDFs.



Development and Test



MID States readiness for restart and recovery
















Flexibility Provisions and Extension of Validity Periods for Licenses, Ratings and Certificate




