#### 1. Introduction

- 1.1 The Provisional Agenda for the Seventh meeting of the RASG-MID Steering Committee (RSC/7) was circulated to States and concerned International Organizations as an attachment to the MID Regional Office Invitation Letter Ref.: ME 4/1–19/373 dated 10 December 2019, as shown in **Appendix A**.
- 1.2 The meeting may wish to note that Mrs. Suha Daher, Commissioner, Civil Aviation Regulatory Commission (CARC) Jordan has left CARC and will not be able to resume the position of the RSC Co-Chair. In addition, Mr. Ken Sewell, Ex-Regional Director, Safety and Flight Operations, Middle East & North Africa, IATA, is not able to the other position of the RSC Co-Chairs.
- 1.3 With respect to the Alt Co-Chairs, Mrs. Angie A. Abdalla Mostafa, the Alt Co-Chair, has been assigned as the Representative of Egypt to the ICAO Council. Furthermore, Capt. Souhaiel Dallel from IFALPA has not been actively participating in the RSC activities.
- 1.4 The current list of Chairpersons and Vice Chairpersons of the RASG-MID and Subsidiary Bodies is at **Appendix B**.

- 1.5 According to the RASG-MID Procedural Handbook, the RASG-MID Steering Committee (RSC) Co-Chairpersons should be elected as follows:
  - One Co-Chairperson from member States; and
  - One Co-Chairperson from an RSC International Organization/Industry (Partners).
- 1.6 It is to be highlighted that according to the generic Terms of Reference of the RASGs approved by ICAO Council "The RASGs shall be administered by a chairperson and one or two vice-chairpersons elected from the State-nominated delegates present. The RASGs will establish the cycle of elections. Exceptionally, at the discretion of each RASG, vice-chairpersons or a co-chairperson may be elected from the international and regional organizations, and/or industry present".
