SAFETY, CAPACITY & EFFICIENCY THE A41...

- endorsed the **2023-2025** edition of the Global Aviation Safety Plan (**GASP**).
- endorsed the **seventh edition** of the Global Air Navigation Plan (**GANP**), and supported the **proposed outlook for the eighth edition**
- requested that efforts to **streamline the Standards making process** as well as to **implement performance-based Standards** should continue.
- welcomed the coordination efforts of the **ICAO audit programmes** and endorsed the evolution plan of the **USOAP CMA** for 2023-2024-2025.
- Recognized the need for **voluntary contributions** to support the evolution and operation of the programmes.
- An **update to Assembly Resolution A38-6** on radio frequency spectrum matters
- **Updates to Assembly Resolution 35-15**, to reflect the need for better protection/resilience of CNS systems and GNSS in particular
- **Update to Assembly Resolution 40-7** to accommodate higher airspace operations
- The Assembly supported the actions taken by ICAO in terms of **regional cooperation initiatives RSOO and RAIO Cooperative Platforms and GASOS** (Resolution A40-6)



ECONOMIC DEVELOPMENT

- The Assembly deliberated and agreed, as applicable, on:
 - work on the **economic and financial measures** and experiences of States in **addressing the impact of the COVID-19 pandemic**
 - work on the development of **a draft Convention on Foreign Investment in Airlines**;
 - work on the **international agreement on the liberalization of air cargo services** and on economic guidance for **unmanned aircraft**;
 - work on the development of the **global aviation competitiveness index** by ICAO
- The Assembly endorsed:
 - Continued **update and development of policies**, guidance and tools for economic viability of airports and Air Navigation Services Providers (ANSPs); and
 - Guidance to assist States in addressing their **infrastructure funding and financing needs**;
 - the **Aviation Satellite Account** methodological framework to measure the economic contribution of aviation to national economies
 - the ICAO single set of **long-term traffic forecasts** and **advanced ICAO dashboards**;


