# EIGHTH MEETING OF THE AIR TRAFFIC FLOW MANAGEMENT TASK FORCE (ATFM TF/8)

(Virtual, 31 October – 1 November 2023)

SUMMARY OF DISCUSSIONS

# 1. PLACE AND DURATION

1.1 The Eighth meeting of the Air Traffic Flow Management Task Force (ATFM TF/8) was held virtually, on 31 October and 1 November 2023, using MS Teams.

## 2. OPENING

2.1 The meeting was opened by the ATFM Chairperson Mr. Hamad Al Belushi, Senior Expert - Air Traffic Management, GCAA, UAE, who welcomed all the participants and recalled the main tasks assigned to the ATFM Task Force emanating from the MIDANPIRG meetings. Additionally, he invited MID States as well as International Organizations to support the implementation plan as agreed, in particular Phase 1A. He highlighted that the results of the Survey proved large progress in ATFM implementation on National level in many MID States, which will be the main discussion of this meeting. He thanked all the participants for their attendance and wished the meeting every success in its deliberations.

#### 3. ATTENDANCE

3.1 The meeting was attended by a total of thirty-seven (37) participants from nine (9) States (Bahrain, Egypt, Iraq, Jordan, Oman, Qatar, Saudi Arabia, UAE and USA-FAA) and three (3) International Organizations (AEROTHAI, CANSO and IATA). The list of participants is at **Attachment A**.

#### AGENDA ITEM 2: REGIONAL FRAMEWORK

# Follow-up on MIDANPIRG Outcomes related to ATFM

- 5.3 The subject was addressed in WP/2, presented by the Secretariat.
- 5.4 The meeting recalled the discussion during the MIDANPIRG/20 meeting and appreciation received on the work of the ATFM Task Force, in particular the organization of the MID ATFM Implementation Workshop (Doha, Qatar, 6 7 February 2023) to foster the ATFM implementation in the MID Region. The Workshop provided an opportunity to support the MID States in taking the proper actions required for implementing Phase 1A of the MID ATFM Implementation Plan within the agreed timelines. Additionally, the Workshop was considered a venue for States and international Organizations to share their experience and challenges among the MID ATFM TF members.
- 5.5 Furthermore, the MIDANPIRG/20 meeting encouraged the MID States to use the information presented in the Workshop to support the implementation of Phase 1A, and report progress or challenges to the next TF meeting. The timeline of Phase 1A implementation according to the MID ATFM Plan is agreed to be 31 December 2023.
- 5.6 It was highlighted that the results of the last conducted ATFM implementation survey (on 2018) do not represent the latest developments in the States, based on the updates received by the States. The ATFM TF was tasked to develop and circulate a new survey, including the activities of Phase IA of the MID ATFM Implementation Plan, to the MID States to enable the TF to monitor the actual level of implementation and provide the necessary support, as required.
- Additionally, it was noted with appreciation the offers received for sharing the experience from Qatar and UAE related to the provision of support to the States in ATFM, including support in documentation (regulation and operations manual) and initial training and setup of ATFM unit and OJT training. Also, for benchmarking of the different tools implemented within Sheikh Zayed Air Navigation Centre (SZC), to support ATC workload, thus, enhance Airspace capacity.
- The meeting highlighted that the main purpose of ATFM implementation is to utilize the available capacity; while the States / ANSPs were urged to prioritize Capacity enhancements projects in terms airspace restructure, ATC sectorization and manpower management prior to implementing any ATFM measures.

## Update from APAC ATFM TF

- 5.9 The subject was presented in PPT/8, presented by the Asia and Pasific Region (APAC) ATFM TF Chairperson.
- 5.10 The meeting was apprised with the developments made by the APAC ATFM TF, including the Global development related to the amendment of the ICAO Doc 9971 and the reflection on the APAC ATFM document, including:
  - Alignment with Doc 9971 ATFM solution concept of matching capacity to demand first, followed by demand adjustments through ATFM measures;
  - Added content on ATFM / A-CDM integration;
  - Reference to separate ATFM Daily Plan Exchange Procedure (attached): enabling automated processing of ADPs shared via emails;
  - Reference to separate AFTN/AMHS ICD for communicating ATFM information (attached) using ADEXP SAM, SRM, SLC messages in the interim prior to FIXM 4.2 with appropriate APAC Extension;

- Reference to separate Post-Ops Analysis Recommended Framework (attached);
- Reference to separate Basic Phrases for Cross-Border GDP Coordination;
- Splitting Training & Competency Appendix referred to by Doc 9971 3<sup>rd</sup> edition into a separate document; and
- Updated Performance Improvement Plan and associated Regional ATFM Monitoring & Reporting Form questions.
- 5.11 The meeting noted with appreciation the guidance material provided to the MID Region ATFM TF by APAC ATFM TF, in order to support the further developments of the MID ATFM Plan.
- 5.12 Based on the above, the meeting requested the MID ATFM Core Team to explore the material and to update the Doc 014 accordingly and provide update to the TF meetings.
- 5.13 In addition, the result of current APAC Regional ATFM status was presented to the meeting. The meeting was informed that APAC ATFM Steering Group collects Regional ATFM Monitoring & Reporting Forms on an annual basis to assess regional ATFM implementation progress and identify areas where additional support may be required.

# Results of the MID ATFM Implementation Survey 2023

- 5.14 The subject was addressed in WP/4, presented by the Secretariat.
- 5.15 The meeting recalled the ICAO MID Doc.014: MID ATFM Implementation Plan (available under ICAO MID Website: <a href="https://www.icao.int/MID/MIDANPIRG/Pages/MID-Docs.aspx">https://www.icao.int/MID/MIDANPIRG/Pages/MID-Docs.aspx</a>); in particular Part I, item 5, related to the timelines of implementation Phases, as follows:
  - a) REGIONAL ATFM CAPABILITY PHASE I (2 years)
    - i. Phase IA (Expected implementation duration, 1 year);
    - ii. Phase IB (Expected implementation duration, 1 year); and
  - b) REGIONAL ATFM CAPABILITY PHASE II (3 years).
- Additionally, the meeting recalled the that the ATFM TF was encouraged to develop and circulate a survey to the MID States, including the activities of Phase IA of the MID ATFM Implementation Plan, to enable the TF to monitor the actual level of implementation and provide the necessary support, as required.
- 5.17 The meeting noted with appreciation that the Secretariat, with the support of the ATFM TF Chairperson, developed and circulated the ATFM Implementation Survey 2023 through ICAO MID State Letter (Ref: ME 3/2.1.1 23/193 dated 12 September 2023).
- 5.18 The main areas have been identified and addressed by this questionnaire based on ICAO MID Doc 014 requirement: a total of 41 questions including 38 predefined answers (implemented/Not implemented) and 3 explanatory questions asked States; under the following areas:
  - a) States focal points;
  - b) National regulation, staffing and training;
  - c) Demand analysis;
  - d) Capacity calculations;
  - e) Measures at airports and TMA;
  - f) Measures at ACC sectors;
  - g) Supporting tools;

- h) Enhancements;
- i) ADP and ATFM measures; and
- j) Additional information.

# 5.19 The details of the survey analysis are presented at **Appendix A** which is categorized as follows:

- a) 8 States out of 15 MID States representing 53.3 % participated in this activity;
- b) the level of implementation was found as follows:

- c) the overall implementation of ATFM Phase IA requirements was 60 %.
- 5.20 Based on the above, the meeting identified the following common areas to foster the implementation of MID ATFM Phase IA:

5.21 The meeting agreed that for the coming period, the Task Force will focus on the items identified above, and encouraged the MID Office to include, in its plan for the year 2024, further implementation support activities to enhance the level of implementation.

# States' Experience and Challenges

- 5.22 The subject was addressed in PPT/5A and PPT/5B, presented by Iraq and Saudi Arabia, respectively.
- 5.23 The meeting noted with appreciation the efforts made by Iraq and Suadi Arabia in implementing relevant parts of Doc 014; mainly related to traffic demand and capacity calculations; and highlighted that the exchange of operational data will enhance the efficiency of Traffic movements. The meeting encouraged the States to use the experience presented in further development of the ATFM in their FIR.

# Review and Update MID ATFM Implementation Action Plan

- 5.24 The subject was addressed in WP/6, presented by the Secretariat.
- 5.25 The meeting reviewed and updated the MID ATFM Action Plan, as at **Appendix B**.

#### AGENDA ITEM 3: FUTURE WORK PROGRAMME

- 5.26 The subject was addressed in WP/7, presented by the Secretariat. The meeting reviewed ATFM TF Terms of Reference, as at **Appendix C**.
- 5.27 The meeting agreed that the ATFM TF/9 and TF/10 meetings be planned as follows:
  - ATFM TF/9 meeting: June 2024 (2 days) Workshop (2 days); MID Office, Cairo.
  - ATFM TF/10 meeting: Q4/2024, virtual (2 days).
- 5.28 The exact dates will be coordinated between the ICAO MID Office and the Chairperson of the ATFM Task Force.

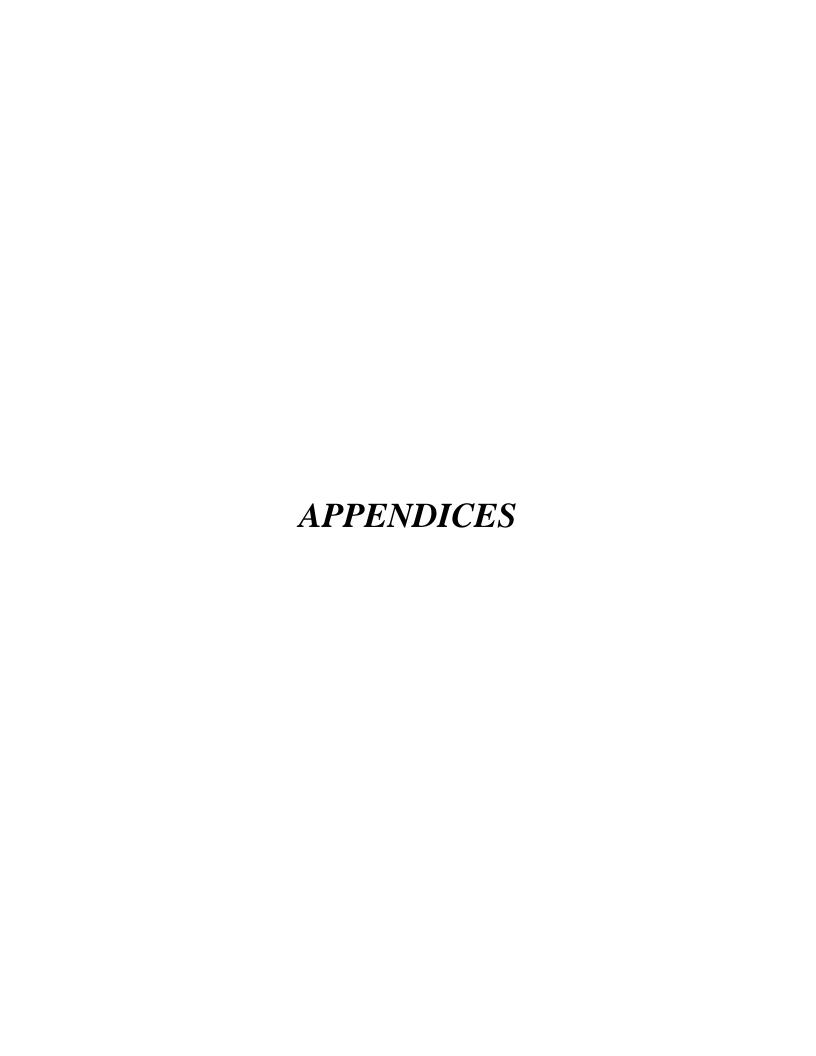
# AGENDA ITEM 4: ANY OTHER BUSINESS

- The meeting noted with appreciation the presentation provided by the MID ATFM Core Team member, Mr. Stuart Ratcliffe, regarding the modern technology utilized to support ATFM implementation and addressing common challenges such as: demand prediction and accuracy, regional ATFM, LR-ATFM, TBO, FF-ICE, and cost of ATFM implementation.
- 5.30 It was highlighted that the Global Satellite data now being readably available a common surveillance picture of all traffic can be used in ATFM. This surveillance data integrated into Cloud-based ATFM systems enables easy implementation of ATFM units from a technical perspective. Cloud based systems require no hardware infrastructure on site allowing for ATFM to be carried out from a regular PC station connected to the internet.

# 6. CLOSING

- Mr. Hamad Al Belushi, the Task Force Chairperson thanked all participants for their active participation, fruitful discussion, and valuable outcomes. Additionally, he highlighted that the traffic demand within the MID Region has recovered and, in some cases, exceeded the levels prior to COVID-19, which will put the pressure on the need for ATFM solutions to support this demand in the most safe and efficient manner.
- 6.2 The participants thanked ICAO for organizing such a fruitful meeting and the follow-up actions.

#### Air Traffic Flow Management (ATFM) Survey 2023

#### Objective:

This ATFM Survey 2023 is prepared and circulated in accordance with the outcomes of the ATFM TF/7 (Doha, Qatar, 8-9 Feb 2023), the result will be reviewed by ATFM TF/8 before presenting to ATM SG/9 planned in November 2023 for further process.

#### History:

The ATFM TF/7 meeting noted that the results of the last ATFM implementation survey (conducted on 2018) are not representing the latest developments by the States, and encouraged the ATFM TF to develop and circulate a new survey, including mainly the activities of Phase IA of the MID ATFM Implementation Plan (MID Doc 014), to the MID States to enable the TF to monitor the actual level of implementation and provide the necessary support, as required.

Based on the above, ATFM TF/7 meeting agreed on the development and distribution of the ATFM implementation survey by the Secretariat supported by the Chairperson.

#### Methodology:

In this survey, a questionnaire is developed in accordance with ICAO MID Doc 014 (MID ATFM plan) implementation phase IA only. the questionnaire is composed of an objective and direct questions, to allow solid analysis of responses. States that are ahead of Phase 1A of the MID Region Plan, are requested to elaborate on their current implementation in the text box at the end of the questionnaire; also, they are invited to share their experience in the implementation with the ATFM TF members.

#### **Duration:**

This questionnaire consists of 40 questions and expected to take 30 minutes to complete.

# TERMS OF REFERENCE (TOR) OF THE MIDANPIRG AIR TRAFFIC FLOW MANAGEMENT TASK FORCE (ATFM TF)

#### I. TERMS OF REFERENCE

- 1.1 Perform a joint assessment and confirmation of the Pre-requisites for a regional ATFM solution, this shall include:
  - a) Assessment of the performance objectives of the individual participating States and definition of common performance objectives for a regional ATFM service.
  - b) Perform a data collection and analysis to identify hot-spot areas and critical times in a regional ATFM service area where demand consistently exceeds capacity. The reasons and contributing factors for unbalanced demand and capacity are to be identified.
  - c) Analysis of air traffic flows within the designated area of the regional ATFM service that is causing unbalanced demand and capacity. The analysis shall identify the traffic fractions that due to their uniformity are candidates for effective ATFM measures to increase the efficiency without violating the equity principle.
- 1.2 Develop an ATFM Concept of Operations and a Framework which addresses ATFM minimum requirements for the implementation of ATFM in the ICAO MID Region.
- 1.3 Agree on a mechanism to support the phased implementation of ATFM measures in the MID Region, when and where required.
- 1.4 Identify, research and recommend appropriate guidance regarding:
  - a) Aerodromes and Airspace capacity under the normal circumstances and adjustment factors affecting the capacity;
  - b) regular review for all aerodromes and ATC sectors where traffic demand is expected to reach capacity, or is resulting in traffic congestion;
  - c) regular review of the implemented ATFM measures and the related publications; to support implementation of the required measures and reflection by the data houses (such as: Flight Planning Systems) and compliance of the airspace users;
  - d) mechanisms for ATFM data gathering, and exchanging operational data related to airspaces/aerodromes availability and air operation data between States, ANSPs, Airspace users, Organizations and ICAO, which may include:
    - i. adjusted aerodromes and enroute capacity due to factors affecting capacity such as:
      - Amid and after crisis management measures (mainly related to ANS Business Continuity Plans and recovery);
      - special use airspace status, runway closures; or
      - weather phenomena.

- ii. traffic demand information which may include flight schedules, flight plan data, repetitive flight plan data as well as associated surveillance updates of flight status; and
- iii. ATFM Daily Plan.
- e) measure compliance of airspace users with the applicable ATFM measures; and
- f) any other guidance relevant to the Regional ATFM Framework.
- 1.5 Consider existing and planned ATFM initiative in the Region and make specific recommendations to ensure their alignment.
- 1.6 Ensure inter-regional ATFM harmonization with adjacent ICAO Regions.
- 1.7 Recommend appropriate inputs related to the implementations of ASBU Elements / Threads relevant to ATFM such as NOPS, A-CDM, etc.
- 1.8 Report to the ATM SG.
- 1.9 Review periodically its Terms of Reference and propose amendments as necessary.

Coordinate as deemed necessary with the relevant MIDANPIRG Sub-Groups and the Regional initiatives, matters of mutual interest.

#### II. COMPOSITION

- 2.1 The Task Force is composed of MID ATFM focal points and experts from:
  - a) MIDANPIRG Member States;
  - b) India, FAA, AACO, ACAO, AEROTHAI, CANSO, EUROCONTROL, IATA, and ICAO (Bangkok, Cairo, Paris Offices and HQ); and
  - c) other representatives from provider States and Industry may be invited on ad hoc basis, as observers, when required.
- 2.2 The Task Force shall elect a Chairperson to act as the point of contact on behalf the Task Force.
- 2.3 ICAO MID Office will act as the Secretary of the ATFM Task Force meetings.

# III. WORKING ARRANGEMENTS

- 3.1 The Chairperson, in close co-operation with the Secretary, shall make all necessary arrangements for the most efficient working of the Task Force. The Task Force shall at all times conduct its activities in the most efficient manner possible with a minimum of formality and paperwork (paperless meetings). Permanent contact shall be maintained between the Chairperson, Secretary and Members of the Task Force to advance the work. Best advantage should be taken of modern communications facilities, particularly videoconferencing (Virtual Meetings) and e-mails.
- 3.2 Face-to-face meetings will be conducted when it is necessary to do so.
