Plans

Coordination, Communication and Decisions Making.

- ▶ Higher Committee for Health Emergencies headed by transitional sovereignty council.
- ▶ Higher Coordinating Committee under Federal ministry of health supervision and member of all partners.
- ▶ CAA Health emergency committee .
- ▶ KRT.AP. Health emergency committee.
- ▶ FAL committee at Khartoum airport includes all relevant sectors.

Arrangements

► COVID19

After WHO announced the break out of a new strain of covid so called covid 19 started in China - republic of Sudan prepared early to implement control measures to arrival PAXS from affected areas

CAA and FMOH lead the committee to coordinate , communicate to prepare and implement the health measures this committee including KRT.A/P authority , airlines , handling services providers . Immigration , Customs .

All resources & efforts directed to control measures and airport setup.

Arrangements

- ❖ Revising KRT.A/P. Health Emergency Plan.
- ❖ Co-ordination between Health Quarantine, Civil Aviation by circulating the instructions to all concerned (Airlines, Ground Handling).
- ❖ Establishing an isolated area by the support of IOM organization to accommodate those infected with positive results.

Arrangements

- ❖ **KRT.A/P.** Conducted a regular awareness programme regarding risk mitigation and risk management ,with co-ordination of both H.Q. and civil aviation authority.
- ❖ **KRT.A/P.** with co-ordination with H.Q. follows and solve PAXS daily problems , specially those who lost their covid certificates or arrived without certificates and they need special handling.
- ❖ **KRT.A/P.** assigned a covid 19 LAP to deal with PAX(S) who need recheck (lost certificates, has no certificates, fake certificates.)
- ❖ **KRT.A/P** co-coordinating a regular (FAL. And airport health committees) meetings to discuss and solve hot problems related to pandemic.
- ❖ **KRT.A/P.** issues and prepares a daily movement schedule in regards to covid 19 procedures and requirements (with minimum 3 hours intervals)

Arrangements


- ❖ Suspected PAX(S) if found **POSITIVE** may transferred to the isolated area ,home quarantine under H.Q supervision or discharged home if found **NEGATIVE**.

Arrangements

- ❖ **KRT.A/P.** Add an extension TENT to arrival terminal to avoid crowding and to obtain more spaces and distancing.
- ❖ **KRT.A/P.** Organized the PAX(S) movements from aircraft to arrival terminal by minimizing the amount to specific NO (Just 20 per bus), out of 70 PAX.
- ❖ **KRT.A/P.** with co-operation with GIAD company prepared sanitizer doors for both arrival and departure terminals, covering PAX body and his accompanying baggage's.
- ❖ **KRT.A/P.** with co-operation with I O M distributes sanitizers, gloves and masks to all aviation communities related to the field of operations (migration,customs,other entities).



At 25 January started health procedure by :-

- ▶ Received notification for any suspected case on flight.
- ▶ deliverable general declaration (part of health) to health authority in arrival.
- ▶ Temperature screening.
- ▶ Optical Screening.
- ▶ referral suspected cases to quarantine.




- ▶ Passenger data entry using electronic system DHIS2 (PLF +PHD form)
- ▶ Stamped sticker in passport to passenger completed health procedure (coordination with immigration authority.
- ▶ Provide guidance material to services providers for operation
- ▶ These procedure Contribute to reduce the spread of Covid cases in the first wave.

Khartoum airport:




The economic impact of the pandemic on Sudan Aircraft operators:

 - Aircraft depreciation.
 - Equipment and machinery.
 - Insurance and human resources.







Highlight to response to pandemics in aviation sector

- ▶ Challenge :-
- ▶ Specialized training in dealing with suspected cases to all staff .
- ▶ Lab test upon arrival need more space ,time ,budget on the other hand it has a severe impacts as(a crowdness).
- ▶ Lack of advance PAX information and coordination between states.

Recommendation

- ▶ Sudan looks forward to receive technical assistance from ICAO middle east region in the following areas :
 - i. Implementing of the health corridor between Sudan and other countries in the region .
 - ii. Assisting in the training of aviation sector stakeholders in the field of health corridor.
 - iii. Assisting in automating health procedures in the aviation sector
