BULLETIN

1. LOCATION

- 1.1 The Competence-Based Training and Assessment approach/Evidence Based Training (CBTA/EBT) Workshop will be held in Dubai, the United Arab Emirates, from 25 to 26 September 2024.
- 1.2 The venue of the workshop will be shared at a later stage.

2. SCHEDULE OF THE MEETINGS

- 2.1 The opening of the workshop will be on 25 September 2024, at 8:30 AM.
- 2.4 The daily schedule will be announced at the opening sessions.
- 2.5 The workshop will be conducted in English.

3. REGISTRATION OF PARTICIPANTS

3.1 Participants are requested to show up on the day of the event at the reception desk located at the entrance of the meeting hall. Attendance will be recorded between 8:00 and 8:30 AM. Participants are also requested to wear the identification badge, which will be issued to them at the reception desk.

4. HOTEL RESERVATIONS/RETURN AIRLINE BOOKINGS

4.1 For hotel booking, participants to make their own arrangement.

5. TRANSPORTATION

- Participants are requested to make their own arrangements for transportation from/to the airport and the event venue. However, taxis are available from the airports and hotels to all destinations. Please note that surcharges apply for vehicles leaving Abu Dhabi International Airport as AED 15 for small vehicles and AED 20 for larger vehicles. An extra AED 20 applies for journeys starting from an airport outside Abu Dhabi.
- 5.2 Car rental agencies are located at the arrival hall of the airports' terminals.

6. INSURANCE

Participants are advised to have insurance coverage for any unexpected contingency including transport hazards (taxi, buses, rented cars, etc.), as well as medical coverage.

VISA

8. CURRENCY, CREDIT CARDS AND BANKING SERVICES

- 8.1 The unit of currency in UAE is Dirhams (AED) with notes of 5, 10, 20, 50, 100, 200, 500 and 1,000. Coins are 10, 25, 50 Fils, and AED 1. The current rates of exchange for the major currencies are available at www.xe.com.
- 8.2 Currency exchange centers and ATMs are available at the airports and major shopping destinations. Commercial banks and currency exchange centers typically operate from 8:00 AM to 4:00 PM, Monday to Saturday. On Fridays, their hours are from 8:00 AM to 12:00 PM to accommodate the Friday prayer.
- 8.3 Hotels, stores, and restaurants typically accept international credit cards like Visa, MasterCard, and others.

9. OTHER USEFUL INFORMATION

DRINKING WATER

9.1 It is recommended that visitors drink bottled water/beverages, however, tap water is safe for drinking.

TELEPHONE

9.2 Mobile sim cards are available at the service providers' outlets at the airport's arrival hall and all major commercial centers.

10. WEATHER CONDITIONS

10.1 The average temperature in November is 25°C, made up of daytime averages of 31°C and night averages of 18°C. Please refer to www.accuweather.com for further updates.
