I have the honour to invite your Administration/Organization to the Free Route Airspace (FRA) Workshop and the First Meeting of the Airspace Management Working Group (ASM WG/1) which will be kindly hosted by Qatar Civil Aviation Authority (QCAA) in Doha, Qatar, back-to-back on **30 September 2024** and **1 – 2 October 2024** respectively, at Qatar Air Traffic Control Centre (QATCC) (https://goo.gl/maps/WLzYo1ZeBps4vPA47).
