


Objective

RASG-MID Organizational Structure


The RASG-MID/7 Meeting, through RASG-MID Decision 7/10 endorsed the revised RASG-MID Organizational Structure, based on the feedback and proposals received from the stakeholders and different RASG-MID subsidiary bodies, with the establishment of the following Groups:

- Annual Safety Report Group (ASRG)
- Aerodromes Safety, Planning and Implementation (ASPIG)
- Safety Enhancement Implementation Group (SEIG)
- Accident and Incident Investigation (AIIG)

The discussion and agreement by the two Groups should take into consideration the:

- new generic Terms of Reference of PIRGs & RASGs approved by the President of the Council on 7 August 2020 mandating the need for PIRGs & RASGs to meet on annual basis
- DGCA-MID/5 Conclusion 5/2 related to the frequency of the MIDANPIRG and RASG-MID meetings
- objective to enhance standardization between the regional groups to the possible extent
- successful experience of organizing the MIDANPIRG and RASG-MID meeting concurrently

Frequency of the meeting

- MIDANPIRG be organized on annual basis in an alternate manner between face-to-face and virtual meetings; and dissolved the MSG accordingly.
- RASG-MID may consider similar approach to enhance standardization between the regional groups to the possible extent, as well as the successful experience of organizing the MIDANPIRG and RASG-MID meeting concurrently
- In case of virtual meetings, do we still need to organize the MIDANPIRG and RASG-MID meeting concurrently?

Fast track/ Approval by passing

- based on a request from States, MIDANPIRG and RASG-MID, the MID Office sent a State Letter on the subject to States and there was no consensus reached on the best way forward, in particular there was not a clear support to go ahead with a new procedure for “Fast Track Procedure / Approval by passing”
- No consensus could be reached neither for MIDANPIRG nor for RASG-MID

Delegation of Authority

- MSG/7 agreed that the delegation of authority to MIDANPIRG Sub-Groups be reconsidered.
- RASG-MID may consider to defer the decision on this subject to the next RASG-MID meeting.
