**1. INTRODUCTION**

1.1 The ICAO Council approved the new eANP Template (Volumes I, II and III) and corresponding procedure for amendment on 18 June 2014 (202nd session, fourth meeting).

1.2 The meeting may wish to note that Volume III contains dynamic/flexible plan elements providing implementation planning guidance for air navigation systems and their modernization taking into consideration emerging programmes such as the ASBUs and associated technology roadmaps described in the GANP. The ANP Volume III also includes appropriate additional guidance, particularly with regard to implementation, to complement the material contained in the ANP Volumes I and II. The amendment of Volume III does not require approval by the Council (approval of Part II is under the responsibility of the relevant PIRG).

**2. DISCUSSION**

2.1 The meeting may wish to recall MIDANPIRG/21 Conclusion 21/3 as follows.

*MIDANPIRG CONCLUSION 21/3: NATIONAL AIR NAVIGATION PLAN (NANP)*

*That, the MID States with support of ICAO MID Office develop their National Air Navigation Plan (NANP) by end of December 2024.*

2.2 Based on the above conclusion and MIDANPIRG/21 report para. 5.2.19, the ICAO MID Office issued State Letter AN 1/7 – 24/185 dated 15 December 2024 to collect the following information and updates from MID States:

- a) update on the status of implementation of the priority 1 ASBU Threads/Elements;
- b) progress achieved in the implementation of the Performance Based Approach and development of State National Air Navigation Plan (NANP), by completing the Questionnaire; and
- c) State's major achievement(s)/success story(ies) in the air navigation field in 2024.

2.3 Regarding the implementation status of the Performance Based Approach (PBA) within the MID Region, **Appendix A** presents the activities undertaken by ICAO MID and the progress made by States in developing their National Air Navigation Plans (NANP).

3.1 The meeting is invited to:

- a) note the ICAO MID activities and the progress made by States in developing their National Air Navigation Plans (NANP) at **Appendix A**; and
