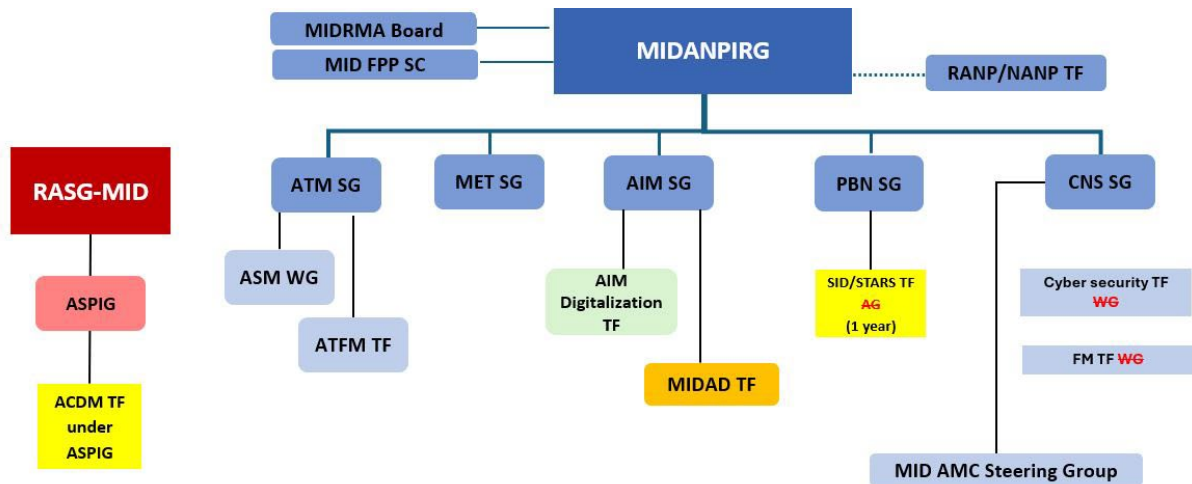
**1. INTRODUCTION**

1.1 The meeting may wish to call the discussion during the MIDANPIRG/21 meeting (Abu Dhabi, UAE, 4 – 8 March 2024), particularly related to the outcomes of the Action Group established during the meeting to review the number and tasks of experts group established under MIDANPIRG subgroups, and the agreed on the following decision:

*MIDANPIRG DECISION 20/33: MIDANPIRG REVISED STRUCTURE*

*That, the revised MIDANPIRG Structure 2024 is endorsed to be included in MIDANPIRG Procedural Handbook.*

2.1 The meeting may wish to note, that since the last MIDANPIRG meeting, the revised structure has met the expectations and relieved the experts group members and the secretariat from duplicate tasks and further meetings; additionally the meeting may wish to note that a revised Terms of Reference (ToRs) of the ATM and ASM were drafted and presented to the MIDANPIRG to ensure assignment of all the relevant tasks.

2.2 Accordingly, the meeting may wish to note that the Terms of References of the ATM and ASM were reviewed accordingly.

2.3 The meeting may wish to note during MIDANPIRG/19 meeting (Riyadh, Saudi Arabia, 14 - 17 February 2022), Mr. Ahmed Al Jallaf, Assistant Director General Air Navigation, GCAA, UAE, and Mr. Saleh Al Nesf, Head of Integrated Management System, QCAA, Qatar, were elected as Chairperson and as First-Vice Chairperson of MIDANPIRG. They assumed their chairmanship for 3 meetings.
