## **Documentation Requirements for Registration**

#### **Member States and Government Officials**

A formal **Letter of Designation/Nomination** from a Member State, on official letterhead and signed by the highest authority for the government entity of the State, is required to qualify for free registration(s). The letter should be addressed to the ICAO Secretary General in response to **2025 ICAO Aviation Climate Week State letter 25/14**. Please include the full name, title, and email address for each nominee.

Once approved by ICAO, voucher code(s) will be provided to the individuals nominated by the State with instructions on the free registration process.

## **International Organizations**

A formal **Letter of Designation/Nomination** from an international organization (IO), on official letterhead and signed by the Head of the IO, is required to qualify for free registration(s). The letter should be addressed to the ICAO Secretary General in response to **2025 ICAO Aviation Climate Week State letter 25/14**. Please include the full name, title, and email address for each nominee.

Once approved by ICAO, voucher code(s) will be provided to the maximum of two (2), nominated individuals with instructions on the free registration process.

Please note that only international organizations which are recognized by ICAO can register to attend in this category. The following link contains a list of **recognized IOs**: <u>List of International Organizations</u>.
