Despite the enormous economic resources generated by air transportation, victims and their families are greatly forgotten after the spotlight of a tragedy fades.


No financial resources to support our activity.



- Progress status of the 30 recommendations of the AAAVF 2021, only 5 are complete, the others are in progress.
- Updated implementation data for Doc 9998.
- Facilitation Working Groups.
