Mrs Folasade Odutola assumed duties as Director, Air Transport Bureau on 7 May 2007. She holds an MSc in Air Transport Engineering from Cranfield University, and a BSc (First Class Hons.) in Aeronautical Engineering from the University of Glasgow, both in the UK. Mrs Odutola has worked in the aviation industry since 1977, mostly within the regulatory sphere.

Immediately before taking up the position with ICAO, Mrs Odutola was Rector and CEO of the Nigerian College of Aviation Technology, an ab-initio training institute for all aviation professionals. Prior to that, she worked briefly in an airline followed by an over 20 year stint in the Nigerian civil aviation regulatory system, where she attained the position of Director, Airworthiness and Operations Standards. She has served as secretary/member of many committees set up to consider issues of high importance to the Nigerian aviation industry while she organized a number of ICAO joint workshops. Mrs Odutola was charged with the responsibility of setting up the very first air transport licensing branch in the regulatory authority where she also handled commercial duties. She has participated in several bilateral air services agreement meetings as well.

Dr Olumuyiwa Benard Aliu is the Representative of Nigeria on the Council of the International Civil Aviation Organization (ICAO), effective from 1 January 2005. He is the Chairperson of the Steering Committee of AFI Comprehensive Implementation Programme (ACIP) charged with the implementation of the AFI Plan - a major safety initiative of ICAO for African States. He was also the First Vice President of ICAO Council, the Chairman of the Technical Cooperation and the Chairman of the Finance Committee of the ICAO Council. Dr Aliu is a member of the Air Transport, Human Resources and ICAO Staff Pension Committees, the Working Group on Policy and Governance, and several other ICAO Committees and Working Groups

A Doctor of Philosophy in Technical Sciences, specializing in Aeronautics, Dr Aliu commenced his aviation training at the then Kiev Institute of Civil Aviation Engineers, now the National Aviation University in Kiev, Ukraine, where he graduated in 1983 with a MSc. Degree in Aeronautical Engineering. He was conferred PhD in 1987. He also obtained Aircraft Maintenance Engineer's Licence with Airframe and Engine ratings on several aircraft types. Dr Aliu, over the course of his career, received training in airworthiness, air transport economics, aviation law, airports and air navigation management as well as in Safety Management Systems (SMS). He is an ICAO certified SMS Instructor. He has an IATA Diploma in Civil Aviation Management and he also obtained a Graduate Certificate in Air and Space Law from the McGill University, Canada.

Dr Aliu joined the Nigerian Ministry of Aviation in 1988 as Senior Air Worthiness Surveyor. His professional experience includes several years with the Nigerian Civil Aviation Authority (NCAA), where he held positions of increasing responsibility in safety oversight and economic regulation. He has also served as Technical Adviser to the Minister of Aviation from 1998-1999. He played an active role in the formulation of the National Civil Aviation Policy leading to commercialization, liberalization and institution of competition and consumer protection programmes in the Nigerian air transport industry. As Director of Air Transport Regulation of NCAA from 2000-2004, he coordinated activities in the regulation of air transport and advised on aviation policies, and in negotiations of Bilateral and Multilateral Agreements. He was also assigned the role of Acting Director-General of Nigerian CAA on several occasions.

Dr Aliu is a member of several aviation, engineering and management professional bodies. He has been a speaker and moderator in many international air transport conferences and seminars. He was President of the ICAO Conference on Aviation and Alternative Fuels in 2009. He led the Nigerian delegation to the 12th Session of the ICAO Facilitation Division in 2004 and was a member of the Nigerian Delegation to the ICAO Assembly in 1998, 2001, 2004 and 2007. Dr Aliu has chaired and served in several regional and sub-regional experts committees of the African Union (AU), the African Civil Aviation Commission (AFCAC), the Economic Community of West African States (ECOWAS) and the Banjul Accord Group (BAG). He has over the past two decades been closely involved with the development and evolution of air transport policies in Africa, including the Yamoussoukro Decision on liberalization of Air Transport in Africa. He is currently working with the AU Commission on the development of a common African Civil Aviation Policy, a programme initiated by him and approved by the Committee of Ministers and the AU Assembly.

Dr Djibo has been the Secretary General of AFCAC since January 2007. He was a member of the Boards of Directors of ASECNA and Air Afrique for 10 years. Dr Djibo directed, managed and supervised all the various aspects of civil aviation (legal, economical, financial and technical) in Africa, in a civil aviation administration, as Director General DGCA of Niger for 10 years, and in an airline as General Manager for Mali of Air Afrique. He has also been an international Project Coordinator for UNDP/ICAO and an Air Transport Officer at AFCAC and ICAO WACAF Office for 7 years.

Mr Samuel Gaiya joined AFCAC in March 2009. He was the pioneer Company Secretary/Legal Adviser of the Nigerian Civil Aviation Authority from 2000 to 2009 where he left as Director, Legal Services in March 2009.

Mr Gaiya holds an Honours Degree in Laws from the Ahmadu Bello University Zaria, Nigeria in 1978 and was called to the Nigerian Bar as a Solicitor and Advocate of the Supreme Court of Nigeria in June 1979. He was appointed a Notary Public for Nigeria in 1986 by the Chief Justice of Nigeria. He holds a Diploma in Civil Aviation Management from IATA in 2005. Prior to joining the Nigerian Civil Aviation Authority he had wide experience as a Senior State Counsel, Private Legal Practice, and held senior management positions in the Banking Industry in Nigeria between 1980 and 1997.

He is a member of the African Union (AU)/AFCAC Panel of Legal Experts on civil aviation matters since 2000. He chaired the Experts Committee meetings that developed the African Guidelines and Clauses for inclusion in all BASA's to be entered into with the European Union in 2004/2005.

Mr Gaiya coordinated the review of the 1964 Nigerian Civil Aviation Act to a new Act that was promulgated into law in 2006. He also coordinated the review of the 1969 AFCAC Constitution which was adopted in December 2009 and entered into force on 11 May 2010. He was 1st Vice Chair ICAO Legal Committee 2005/2007, a Member of the ICAO Commission of Experts of the Supervisory Authority of the International Registry 2006/2009, and a Member of the special Sub-Committee of the Legal Committee that finalized the Draft Texts of the Aviation Security Convention and Protocol, which were subjected to the Diplomatic Conference and adopted in Beijing, China in September 2010.

Mr Gaiya was a Member of the Experts Panel that drafted the Banjul Accord Group (BAG) Agreement and Multilateral Air Services Agreement in 2000, and a Member of the Drafting

Committee of the Cape Town Convention and Aircraft Protocol in 2001. He was a Member of various Nigerian Government bodies and delegations, and of various ICAO, AU and AFCAC Panels and Committees from 2000 to date, as well as a Member of the Nigeria Bar Association and International Bar Association.

Mr Gaiya was an Alumnus of the London Management School 2004 and Fellow Certified Board of Administrators of Nigeria (FCBAN).

He has presented many papers on topical issues in International Air Law around the world.


Mr Alfonso Cabrillo Losada
