**EXECUTIVE SUMMARY**

In accordance with Assembly Resolution A36-31, draft scales of assessment to the General Fund for the years 2011, 2012 and 2013 are included in the Appendix to this paper.

These draft scales were calculated on the basis of the principles set out in Clause 1 of the above Resolution.

The current methodology was first adopted at the 12th Assembly session held in 1959, during which the Assembly issued Resolution A12-30, setting out the basic principles for the calculation of the scales of assessment. Thereafter, other than changing the minimum and maximum levels of assessment, there has been no substantive change in the methodology. The Council has agreed that it is appropriate to comprehensively review the methodology and the basic principles to determine if a change is warranted. A special working group composed of Council Members and the Secretariat has been established to carry out a thorough study of the methodology and to come up with recommendations, for consideration during the next ordinary session of the Assembly.

**Action:** The Assembly is invited to request its Administrative Commission to establish, as usual, a Contributions Working Group to review the full details of the calculations made to arrive at the draft scales in the Appendix.
