ASSESSMENTS OF CONTRIBUTIONS OF NEW CONTRACTING STATES

SUMMARY

This report seeks adoption by the Assembly of a resolution approving the action taken by the Council in assessing a new Contracting State of ICAO.

Action by the Assembly: Paragraph 3

1. Subsequent to the 33rd Session of the Assembly, the following State adhered to the Convention and became a Contracting State of ICAO:

Name of New Contracting State	Date of Adherence	Date of Membership	Date from which Assessable	Assessment Rate
Saint Kitts and Nevis	21 May 2002	20 June 2002	1 July 2002	0.06%

2. Acting under Financial Regulations 6.9 and 7.5 (Doc 7515/11), the Council determined the assessment of contributions to the General Fund and the advance to the Working Capital Fund of the new Contracting State to be at the rate as shown in paragraph 1. The Council, at its fourth meeting of the 167th Session (C-DEC 167/4), established the contribution of U.S.\$ 14 982 and the advance to the Working Capital Fund of U.S.\$ 3 600, pertaining to the last six months of 2002. In the **Appendix** is the draft Assembly Resolution confirming the action for approval by the Assembly.

ACTION BY THE ASSEMBLY

3. In accordance with Financial Regulations 6.9 and 7.5, the assessment of a new Contracting State is reported to the Assembly for it to approve the action of the Council by adopting the draft Resolution in the Appendix.

APPENDIX**DRAFT RESOLUTION FOR ADOPTION BY THE 35TH SESSION OF THE ASSEMBLY****Resolution 40.1/1****Confirmation of Council action in assessing the contributions to the General Fund and determining advances to the Working Capital Fund of States which have adhered to the Convention**

The Assembly:

1. *Notes* that:
 - a) Financial Regulations 6.9 and 7.5 provide that the Council shall, if the Assembly is not in session, determine the assessment of contributions and the advance to the Working Capital Fund of a new Contracting State, subject to approval or adjustment at the next session of the Assembly; and
 - b) the Council has acted accordingly in respect of the State which became a member of the International Civil Aviation Organization after the 33rd Session of the Assembly, and assessable, as indicated below;
2. *Confirms* the action of the Council in assessing the contribution and the advance to the Working Capital Fund of the following State at the percentage rate indicated, such assessment rate to apply from the assessable date indicated:
