LEVEL OF INDICATIVE CONTRIBUTIONS FOR THE ICAO AVIATION SECURITY (AVSEC) PLAN OF ACTION

(Presented by the Council of ICAO)

EXECUTIVE SUMMARY

The total funding required by the Aviation Security (AVSEC) Plan of Action for the period 2008 – 2010 is U.S.\$ 17.9 million. The costs of the AVSEC Plan of Action are being integrated into the Regular Budget. However, as a result of funding constraints for 2008 – 2010, only about U.S.\$ 8.6 million of the amount required is included in the Regular Budget. The balance of U.S.\$ 9.3 million will have to be funded by a combination of funds carried over at the end of fiscal 2007 and new voluntary contributions. However, the carried forward balance is estimated to be U.S.\$ 4.7 million at the end of 2007. As a result, the Secretariat is requesting approval for a suggested voluntary contribution of an additional U.S.\$ 4.6 million in 2008 to fully fund the programme for the period 2008 - 2010.

Action: The Assembly is invited to:

- a) review the unaudited estimated balance of contributions received for the AVSEC Plan of Action and not utilized in the 2005-2007 triennium (see paragraph 2.2);
- b) review the projections for receipts and expenditures for both 2007 and for 2008 2010 triennium;
- c) request the Secretary General to ask for voluntary contributions in the amount of U.S. \$ 4.6 million in support of the AVSEC Plan of Action for 2008 2010 to be included in the same State letter as that for contributions to the Regular Budget; and
- d) adopt the draft Assembly resolution presented in Appendix C.

Strategic Objectives:	This working paper relates to Strategic Objectives B.
Financial implications:	Based on present projections, the AVSEC Plan of Action will face a potential funding gap of U.S. \$ 4.6 million for 2008 – 2010. If this gap is not closed, AVSEC activities will have to be curtailed.

1. **INTRODUCTION**

- 1.1 The 35th Session of the Assembly in October 2004 unanimously adopted Resolution A35-10: Financial Contributions to the Aviation Security Plan of Action. This resolution, inter alia, expressed appreciation to States for the voluntary contributions received in the form of human and financial resources; endorsed indicative funding requirements from extra-budgetary resources for the AVSEC Plan of Action totalling U.S.\$ 20 million for the financial years 2005, 2006 and 2007; and urged all Contracting States to provide voluntary contributions to finance the implementation of the AVSEC Plan of Action. The suggested contributions are based upon the scales of assessments approved by the Assembly for the Regular Programme Budget for 2005, 2006 and 2007.
- Taking into account advice received from the Committee on Unlawful Interference (UIC) and the Council during the 172nd Session, the Secretary General subsequently issued a State Letter (AS 8/1.5-04/107 Confidential dated 29 December 2004) seeking voluntary contributions for the AVSEC Plan of Action. The letter presented the suggested level of contributions payable by States towards the Plan of Action for the financial year 2005 of U.S.\$ 5.20 million, based on the amounts presented to the 35th Session of the Assembly in A35-WP/49, Addendum No. 1. The letter also explained that, during the first quarter of the year 2005, the actual balance of contributions received and not utilized in the 2002-2004 triennium and the indicative contributions for the years 2006 and 2007 would be submitted to the Council for review and States would be advised of the outcome.
- Based on the funds available for the years 2005 and 2006, the requested voluntary contributions were adjusted to the amounts of U.S. \$ 5.30 million for 2006 and U.S. \$ 5.35 million for 2007. As a result, total voluntary contributions assessed for the period 2005-2007 were U.S. \$ 15.85 million.
- Not all States have been able to make contributions to the voluntary fund. For the period 2005 2006, total receipts were approximately U.S. \$ 6.0 million or 57 per cent of the total assessment. When earmarked contributions are included, the total amount of funding received increases to U.S. \$ 7.71 million or 73.4 per cent of the assessment. A detailed review of receipts and expenditures is included in Appendix D to this paper. As a result of these shortfalls, expenditures for the AVSEC Plan of Action have exceeded assessments received in both fiscal years 2005 and 2006. This trend is forecasted to continue in 2007 unless States take remedial actions to contribute to this important programme.

2. BALANCE OF CONTRIBUTIONS AS AT 31 DECEMBER 2007

- As noted in Appendix D to this paper, the balance of funds available at the end of fiscal year 2006 is U.S. \$ 7.25 million and the suggested voluntary contribution for 2007 is U.S. \$5.35 million. Based on the present trend of receipts, ICAO is forecasting receipts of U.S. \$ 3.21 million during 2007 against a total assessment of U.S. \$ 5.35 million out of which less than U.S. \$ 526 000 has been received by June 2007. Expenditures funded by the AVSEC Plan of Action for 2007 are forecast to be approximately U.S. \$ 5.12 million.
- 2.2 As a result, the balance of contributions remaining unspent as of 31 December 2007 is projected to be approximately U.S. \$ 4.7 million, assuming that U.S. \$ 3.21 million in voluntary contributions are received during 2007.

3. AVSEC PLAN OF ACTION FUNDING REQUIREMENTS FOR 2008 – 2010

- 3.1 As noted in Assembly Resolution A35-10, the funding for AVSEC is to be integrated into the Regular Budget, "progressively, and as soon as possible". The ICAO forecast for programme expenditures in this area is for an increase to a total of U.S. \$ 17.9 million for the period 2008 2010 i.e. approximately U.S. \$ 6.0 million per year.
- 3.2 For the next Budget triennium, ICAO has included the maximum amount of funding possible in the Regular Budget given the funding cap applied to the Regular Budget. As indicated in A36-WP/23, U.S. \$ 8.6 million or 47.9 percent of the total funding required for 2008 2010 has been integrated into the Regular Budget proposals. The balance of approximately U.S. \$ 9.3 million will have to be bridged through the balance of funds remaining at the end of fiscal 2007. If such amount is lower than U.S. \$ 9.3 million, AVSEC activities will have to be reduced accordingly unless new voluntary funding is secured.
- 3.3 Given that the expected balance of funds remaining at the end of 2007 is projected to be U.S. \$ 4.7 million, the shortfall is presently forecast at U.S. \$ 4.6 million. 1

3.4 Given that Security is one of the major Strategic Objectives in the ICAO Business Plan, it is recommended that voluntary contributions be sought from Contracting States in the year 2008 to cover the deficit (U.S. \$ 4.6 million) as indicated in the table above. A schedule of Indicative Contributions for States is contained in Appendix B to this paper based on the 2008 draft scale of assessment. A draft Assembly resolution to this effect is found in Appendix C to this paper.

APPENDIX C

DRAFT ASSEMBLY RESOLUTION FOR ADOPTION BY THE 36TH SESSION OF THE ASSEMBLY

Resolution 15/.. Financial contributions to the Aviation Security Plan of Action

Whereas the development of international civil aviation can greatly help to create and preserve friendship and understanding among the nations and peoples of the world, yet its abuse can become a threat to general security;

Whereas the threat of terrorist acts, unlawful seizure of aircraft and other acts of unlawful interference against civil aviation, including acts aimed at destruction of aircraft, as well as acts aimed at using the aircraft as a weapon of destruction, have a serious adverse effect on the safety, efficiency and regularity of international civil aviation, endanger the lives of persons on board and on the ground and undermine the confidence of the peoples of the world in the safety of international civil aviation;

Recalling its Resolution A35-10;

Endorsing the Aviation Security Plan of Action adopted by the Council to urgently address the new and emerging threats to civil aviation, in particular the establishment of an ICAO Universal Security Audit Programme relating to, inter alia, airport security arrangements and civil aviation security programmes, the review of the adequacy of the existing aviation security conventions and the review of the ICAO aviation security programme, including a review of Annex 17 and other related Annexes to the Convention;

Convinced that aviation security continues to remain a critical and priority programme of ICAO and of the need to establish and implement work programmes in the next triennium to address the issues identified under Assembly Resolution A35-10; and

Noting that the Secretary General had integrated close to 50 per cent of the Aviation Security Plan of Action into the Regular Budget and that the funding required to implement the work programme relating to aviation security could not be fully included within the Regular Budget for 2008-2010 due to budgetary and financial constraints;

The Assembly:

1. *Expresses* its appreciation to the relevant Contracting States for the voluntary contributions in the form of human and financial resources expected to reach at least U.S. \$ [4.6] million by the end of 2008 for the implementation of the Aviation Security Plan of Action during the 2008-2010 triennium;

- 2. *Urges* all Contracting States to, as soon as possible, and preferably as part of their 2008 assessment provide voluntary contributions to finance the implementation of the Aviation Security Plan of Action, the suggested contributions to be based upon the 2008 scales of assessments approved by the Assembly for the Regular Budget;
- 3. *Urges* all Contracting States to make pledges of voluntary contributions in advance and make contributions early in 2008 so as to ensure the proper planning and implementation of the Aviation Security Plan of Action;
- 4. *Urges* the Council to support the long term sustainability of the Aviation Security Plan of Action by continuing to progressively incorporate the funding requirements within the Regular Budget, and accordingly *requests* the Secretary General to make specific proposals for a full integration when preparing the draft Programme Budget for 2011-2013; and
 - 5. Declares that this resolution supersedes Assembly Resolution A 35-10.
