REPORT OF THE TECHNICAL COMMISSION TO THE ASSEMBLY

General

1. The Technical Commission held five meetings between 21 and 26 September 2007.
2. Mrs. Margaret Munyagi (United Republic of Tanzania) was elected Chairman at the Fourth Plenary Meeting of the Assembly. The Commission, at its first meeting, elected as First Vice-Chairman Mr. Asgeír Pálsson, on a nomination by Ukraine, seconded by Portugal. It elected as Second Vice-Chairman, Colonel Eduardo Miers-Schiavo (Paraguay), on a nomination by Brazil, seconded by Barbados.
3. Representatives from 172 Contracting States and 43 Observer Delegations attended one or more meetings of the Commission.
