# ICAO TAG/MRTD

- Agrees that there is a need for standards/best practice to be developed for emergency travel documents in order to protect them from potential use
- Further work by TAG/MRTD New Technologies Working Group (NTWG)

# Standards

- Minimum security standards
- Use of a standard name
- Logo?
- Colour and validity of documents

# Why an emergency passport

- A document that you don't want to issue
  - Full control of the issuance process?
  - Security in the document?
- Compere with the ordinary passport



# Face reality

- Ordinary passports are
  - Stolen
  - Lost
  - Forgotten

# Conclusion

- Citizens behavior results in a need to issue passports that don't follow your standard procedures for ordinary passports

# The task for the passport agency

- Type of document
  - Valid to almost all countries or
  - Only valid for a journey back home
  - It is your choice

# Issuance

- The same process domestically and abroad
- Proof of identity
- Proof of citizenship – access to your records
- Validity of the document

# Place of issuance

- Domestically – all application centers?
- Abroad
  - Embassies
  - Consulates - all?

# The document

- Booklet
- A4/Letter size paper document
- A strategic decision

# Document security

- Most important
  - Integrated photo
  - Visual security features

# Security

- It is a blank document – store in a safe environment
- Keep records
- Upon issuance – register in the passport system

# Fees

- Cover your costs
- Set the fee to avoid emergency passport instead of ordinary passport
- Set the fee to limit the number of emergency passports

# Border control


- A document that alerts the border control
- Facilitate the border control
  - The data of the holder according to Doc 9303 datapage

# Return of the document

- Establish rules and standards for a robust return system
  - Easy at your border
  - Harder at other borders






