Stolen and Lost Travel Document Database (SLTD)

- Record of reported stolen and lost travel documents
 - Passport
 - ID Card
 - Visas etc
- Frontline checks using MIND/FIND

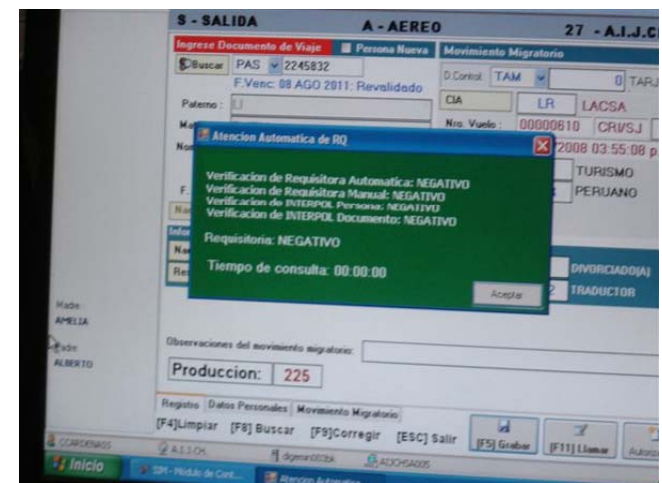

 - Involved 50 police officers
 - 5,000 searches

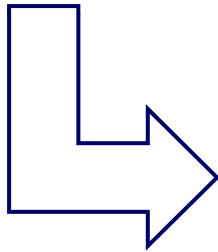

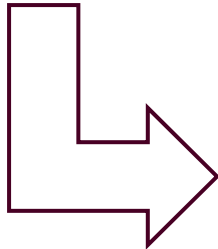
The Vision

Special visa status expedites travel:

- Visa requirement waived;
- Visa automatically issued upon arrival in country;
- Other special visa treatment.
