MEETING ARRANGEMENTS AND TENTATIVE TIMETABLE

SUMMARY

This working paper provides an overview of the administrative arrangements for the second ICAO Conference on Aviation and Alternative Fuels (CAAF2). It includes the agenda, the proposed timetable and other pertinent information related to the convening of the CAAF2.

1. **INTRODUCTION**

- 1.1 The second ICAO Conference on Aviation and Alternative Fuels (CAAF2) will be convened from 11 to 13 October 2017, at the Hotel Intercontinental Presidente, in Mexico City, Mexico.
- 1.2 The CAAF2 is being held pursuant to ICAO Assembly Resolution A39-2: Consolidated statement of continuing ICAO policies and practices related to environmental protection climate change, which reaffirms the need for alternative fuels to be developed and deployed in an economically, socially and environmentally acceptable manner. The 39th Session of the Assembly also welcomed the convening of CAAF2, with the objective of developing an ICAO Vision on Aviation Alternative Fuels.

2. **AGENDA FOR THE CAAF2**

2.1 The agenda for the CAAF2, is included in Appendix A.

3. LANGUAGE OF THE MEETING

3.1 The working languages of the meeting are Arabic, Chinese, English, French, Russian and Spanish.

4. TIMETABLE AND SCHEDULE

4.1 The working hours are proposed as follows:

- 4.2 The meeting will work as a single body and a tentative timetable is attached as Appendix B. - 4.3 The formal introduction of working papers on which specific action is sought by States or observers may need to be restricted in order to maximize the time available for substantive discussion on each of the topics. Information papers (papers not requesting any specific action by the Conference) will not be formally presented. They will, however, form part of the record of the meeting.

- 5.4 This meeting will be conducted on a paper-free basis as much as possible. No documentation posted electronically prior to the meeting will be distributed in hard copy.

- 6.1 Seating arrangements during the meeting are based on pre-registration records and will be progressively updated with information from on-site registration.
- Participants will find their designated seat by the nameplate of their State/organization.
