CORSIA IMPLEMENTATION ON THE GROUND: STATES'
EXPERIENCES AND CAPACITY BUILDING**

Session 2 will elaborate on essential components of the CORSIA package, specifically on data reporting and on upcoming challenges regarding CORSIA Eligible Fuels (CEFs) and CORSIA Eligible Emissions Units (CEUs).
